



SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which Water Right, File No. 27,517 shall be subject to the following conditions:



If the seal is broken without the written permission of the chief engineer, this shall create a rebuttable presumption that the point of diversion had been unlawfully operated in violation of the order of the chief engineer and that the water right holder had been acting in violation of the conditions of his or her water right.



Two (2) applications for approval to change the place of use for the referenced files were received on October 11, 2016. The maps accompanying the applications were returned back to the applicant for signatures on October 12, 2016. The applicant returned the signed maps on October 12, 2016.

On October 13, 2016, two (2) surrounding well owners were notified of the proposed place of use change applications (File Nos. 27517&36789) filed by Jerry Marmie, on behalf of Northglenn LTD and E D & J Inc. Six (6) additional notification letters were sent to surrounding well owners notifying them of the place of use change for File No. 36789.

On October 17, 2016, Kathleen Weikert's father called on behalf of Kathleen inquiring about the notification letter sent on 10/13/2016 (File Nos. 27517&36789). He was wondering how the proposed place of use will affect his daughter's domestic well. He wanted to know if Mr. Marmie was moving the location of his well. I informed him that only the place of use would change and no changes to the well's location will be authorized by the proposed place of use change. He had no other concerns at the end of our phone conversation.

On October 17, 2016, Vicki Wood called to discuss a notification letter (File No. 36789) sent on 10/13/2016. She wanted clarification on the letter. I informed her of the proposed place of use change and clarified that the well location, authorized quantity, and rate of pumping will not be changing with the approval of this application. She indicated that she wanted to check with other sources and will call or write back with any other concerns.

On October 18, 2016, Robert Sanders called regarding a notification letter (File No. 36789) that he received dated 10/13/16. Mr. Sanders was calling to verify that the change would only be to the place of use. He had no other concerns at the time of the call.
