As authorized by K.S.A. 82a-736, the authorized point of diversion for a multi-year flex account term permit will change automatically upon approval of an application to change the point of diversion under the base water right. The referenced approval of application to change the authorized point of diversion under the referenced base water right shall amend the authorized point of diversion of the multi-year flex account Term Permit, File No. 20127606 to reflect the change.

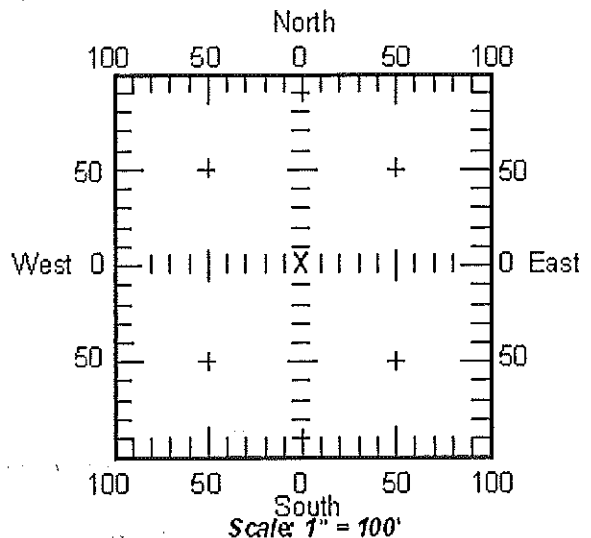

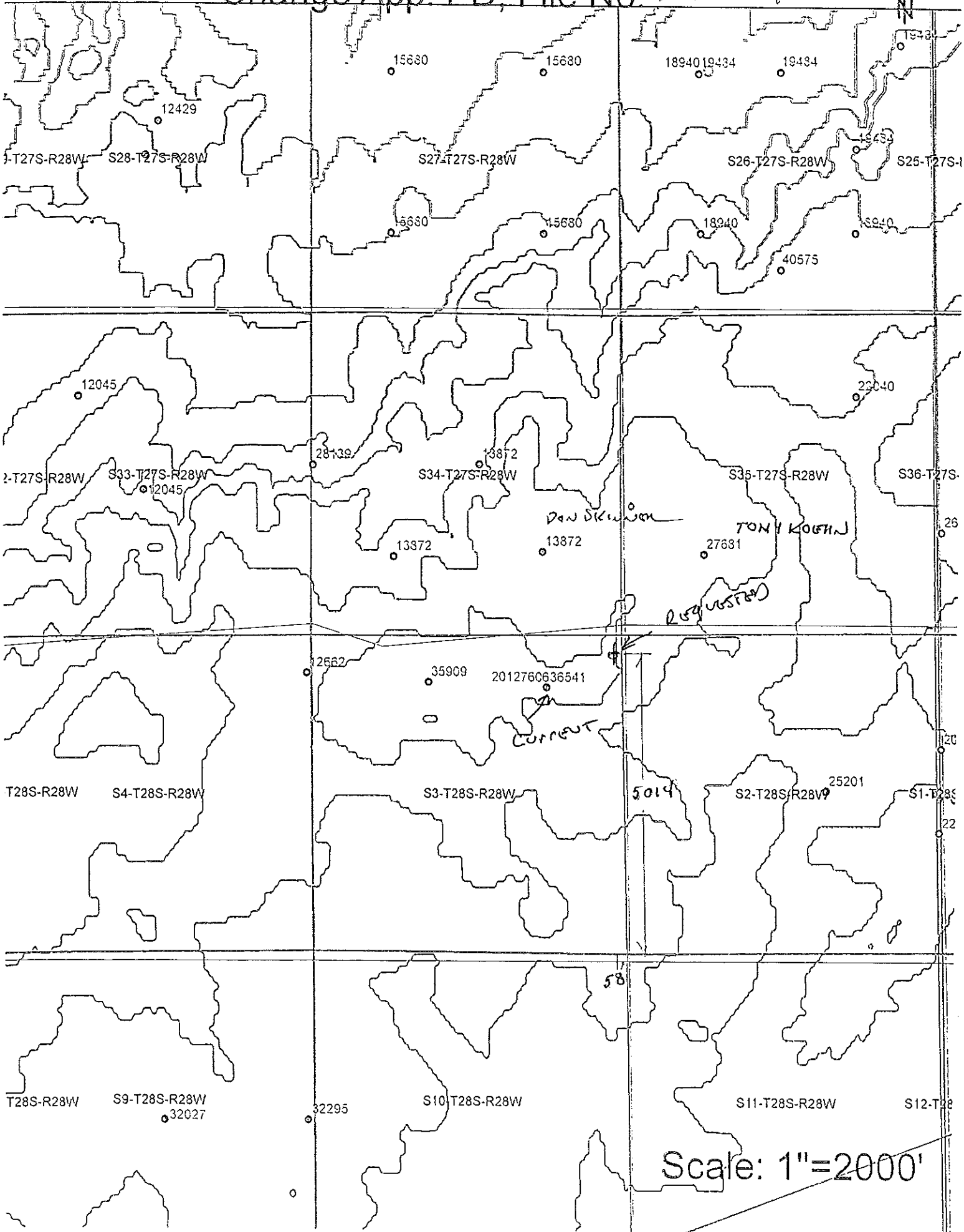
