#### MEMORANDUM

File Nos. 8,515 and 21,910.01

Andy Smaltz on behalf of Rocking Heifer LLC owner of the referenced water rights, has filed applications for approval to change the place of use for File Nos. 8,515 and 21,910.01, authorized for stockwatering use.

The referenced file numbers do not appear to be abandoned as per K.S.A. 82a-718.

All wells within one half mile of either point of diversion are owned by the applicant, therefore, no nearby notifications were sent.

According to the applications, the owners plan to expand their current feedlot capacity 15,000 head to 24,000 head. The total quantity requested for stockwatering under File Nos. 8,515 and 21,910.01 is 80.61 m.g.y. amounts to approximately 9.2 gallons per head per day, which appears to be reasonable for cattle pursuant to K.A.R. 5-3-22 *Maximum reasonable quantity of water for livestock and poultry*.

In a letter dated June 7, 2017, Jason Norquest, Assistant Manager of Southwest Kansas Groundwater Management District No. 3, indicated that applications comply with the current management program and he further recommends approval of the applications at this time.

In an e-mail dated July 12, 2017, Mike Meyer, Water Commissioner of the Garden City Field Office, indicated that he is not opposed to approval of the applications.

Water flow meters are required. Check valves are required if any chemical or foreign substance is injected into the water through the diversion works.

Based on the above discussion, that the changes are reasonable, that impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it is recommended that the referenced applications and reduction request be approved.

#### APPROVAL OF APPLICATION FOR CHANGE IN PLACE OF USE WATER RIGHT FILE NO. 21,910.01

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Andy Smaltz on behalf of Rocking Heifer L.L.C., 439 East Road 4, Ulysses KS 67880, received in this office on February 13, 2017, for approval of a change in the location of the place of use under the certificate of appropriation issued pursuant to the application for permit to appropriate water for beneficial use, as modified and amended by the order of the Chief Engineer, dated April 28, 2003, approving the application to change the authorized use made of water, finds that the change is reasonable and will not impair existing rights and that the application should be and is hereby approved.

The effective date of the change shall be the date this order is executed by the Chief Engineer, the authorized place of use shall be described as:

a feedlot located in the South Half of the North Half of the Southwest Quarter (5½N½SW¼) and the South Half of the Southwest Quarter (5½SW½) of Section 15, and the Northwest Quarter (NW¼), of Section 22, all in Township 27 South, Range 37 West, Grant County, Kansas,

located substantially as shown on the topographic map accompanying the application to change the place of use and use made of water.

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 21,910.01, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated April 10, 2002, as modified and amended by the aforementioned order.

#### RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785)-564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.

Any request for hearing or petition for administrative review shall be in writing and shall be submitted to the attention of: Chief Legal Counsel, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, Fax: (785) 564 – 6777.





Per our phone call Monday, February 20, 2017 regarding the subject change applications, where your cursory review indicated an incomplete application due to lack of contact information for owners of points of diversion within 1/2 mile of the proposed change in place of use-

A review using WIMAS of the area within [Longitude between -101.3833 - -101.2667 Latitude between 37.6833 - 37.7542] and filtered for all active water rights showed that there are no authorized groundwater POD's within 1/2 mile of the POD's authorized for File Nos. 8515 and 21910.01.

A review of the KGS interactive WWC5 map also did not show any domestic wells within 1/2 mile of the POD's authorized by File Nos. 8515 and 21910.01. The WWC5 map did show a well in the NW/4 NW/4 NE/4 Section 22 that was not plugged and was drilled for stockwater in 1996. It was confirmed that there is not an active well at this location.

There is a domestic well on Rocking Heifer, LLC property located within the NW/4 of Section 22 and approximately 80 feet west of the feedlot office. This well supplies water for the feedlot office and employee housing on site. It is possible that the WWC5 well named above was incorrectly described as in the NE/4 and could be Rocking Heifer's domestic well located approximately 400 ft west of the stockwater well's described location instead.


