Benjamin Fuentes, on behalf of Supreme Cattle Feeders L.L.C./Green Plains Cattle Company L.L.C., owner of the referenced file number, filed an application for approval to change the authorized point of diversion, authorized for stockwatering use in the Cimarron River drainage basin.

The referenced water right does not appear abandoned as per K.S.A. 82a-718.

The referenced file number is authorized one standby well and three primary wells with assigned limited quantities and diversion rates for stockwatering use in Section 16, Township 32 South, Range 33 West, Seward County, Kansas. The authorized well in the northwest corner of the section is also authorized by Water Right, File No. 39,772 but there are no other current overlaps in the authorized points of diversion. The authorized place of use is overlapped by Water Right, File Nos. 17,833; 39,722; and 39,734. The water right owner proposes to transfer 90.587 million gallons per calendar year (278 acre-feet) and no additional rate from the well located 3,226 feet North and 3,394 feet West of the Southeast corner of Section 16 to the existing well also authorized by File No. 28,014 located 3,592 feet North and 100 feet West of the Southeast corner of Section 16, a distance move of 3,299 feet. The proposed well will be authorized a total of 157.043 m.g.y. (481.95 AF) and 710 g.p.m., and better described with g.p.s. feet distances of 3,551 feet North and 111 West of the Southeast corner of Section 16. Term Permit Application, File No. 20179042 was filed on June 28, 2017 for 27.8 acre-feet and 710 g.p.m. for the proposed well for the same feedlot to cover any overpumping during processing of the referenced change application.

WRIS and the application map indicate the wells within one-half mile of the proposed existing well are stockwatering wells under common ownership.

The same local source of supply does not appear to change previously determined to be Ogallala Formation (211).

In a letter dated July 13, 2017, Jason Norquest, Assistant Manager of Southwest Kansas Groundwater Management District No. 3 indicated that the referenced application should be approved with a waiver of K.A.R. 5-23-3 since the proposed move is over 2,640 feet and since the proposed existing well does not meet well spacing requirements to two of the stockwatering wells authorized by File Nos. 17,833 and 28,014 under common ownership.


In an e-mail dated August 3, 2017, Michael Meyer, Water Commissioner of the Garden City Field Office, indicated he recommends approval of the referenced change application.

A water flow meter is required. A check valve is required if any chemical or foreign substance is injected into the water through the diversion works.

Based on the above discussion, that the change is reasonable, that impairment to existing water rights is unlikely, that no change in the local source of supply will occur, and if the Chief Engineer waives K.A.R. 5-23-3, it has been recommended that the referenced application be approved.

APPROVAL OF APPLICATION FOR CHANGE IN POINT OF DIVERSION WATER RIGHT FILE NO. 28,014

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Benjamin Fuentes, on behalf of Green Plains Cattle Company, L.L.C. dba Supreme Cattle Feeders L.L.C. 19016 Road I, Kismet, Kansas, 67859-6026, received in this office on May 30, 2017, for approval of a change in the location of the point of diversion under the certificate of appropriation issued pursuant to the application for permit to appropriate water for beneficial use, as modified and amended by the Order of the Chief Engineer dated February 17, 2000, approving the application to change the place of use, and by the Orders of the Chief Engineer dated January 17, 2006 and October 12, 2016, approving applications to change the point of diversion, finds that the change is reasonable and will not impair existing rights, and that the application should be and is hereby approved.

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the authorized location of the point of diversion shall be:

- one (1) well located in the Northeast Quarter of the Northeast Quarter of the Northeast Quarter (NE¼ NE¼ NE¼) of Section 16, more particularly described as being near a point 4,850 feet North and 123 feet West of the Southeast corner of said section (standby well),
- one (1) well located in the Northeast Quarter of the Southeast Quarter of the Northeast Quarter (NE½ SE½ NE½) of Section 16, more particularly described as being near a point 3,551 feet North and 111 feet West of the Southeast corner of said section, at a diversion rate not in excess of 710 gallons per minute (1.58 c.f.s.) and in a quantity not to exceed 157.043 million gallons (481.95 acre-feet) of water per calendar year (primary well),
- one (1) well located in the Northwest Quarter of the Northwest Quarter of the Northwest Quarter (NW½ NW½) of Section 16, more particularly described as being near a point 5,150 feet North and 5,271 feet West of the Southeast corner of said section, at a diversion rate not in excess of 80 gallons per minute (0.17 c.f.s.) and in a quantity not to exceed 32.585 million gallons (100 acre-feet) of water per calendar year (primary well), and
- one (1) well located in the Southwest Quarter of the Southeast Quarter of the Northwest Quarter (SW¼ SE¼ NW¼) of Section 16, more particularly described as being near a point 3,226 feet North and 3,394 feet West of the Southeast corner of said section, at a diversion rate not in excess of 460 gallons per minute (1.02 c.f.s.) and in a quantity not to exceed 90.668 million gallons (278.25 acre-feet) of water per calendar year (primary well).

all in Township 32 South, Range 33 West, Seward County, Kansas,

located substantially as shown on the map accompanying the application to change the point of diversion.

Installation of the works for diversion of water shall be completed on or before December 31, 2017, or within any authorized extension of time. The water right owner shall notify the Chief Engineer of the Division of Water Resources, Kansas Department of Agriculture, when construction of the works for diversion has been completed.

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 28,014, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated February 16, 2000, as modified and amended by the aforementioned orders.

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.

Any request for hearing or petition for administrative review shall be in writing and shall be submitted to the attention of: Chief Legal Counsel, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, Fax: (785) 564 - 6777.

WAIVER OF REGULATION K.A.R. 5-23-3(a)(1) and K.A.R. 5-23-3(b) Well Spacing Requirements

Re: Water Right, File No. 28,014

- 1. That K.A.R. 5-23-3(a)(1) states in part that the minimum well spacing shall be based on the maximum annual quantity of water in acre-feet either authorized and requested for the proposed well, or authorized and requested by a senior application, permit, or water right for the nontemporary, nondomestic well to which the spacing is being measured, whichever is greater.
- 2. That K.A.R. 5-23-3(b) states in part that the location of a well or wells on an application for approval to change the point of diversion under an existing water right shall be no more than 2,640 feet from the currently authorized and completed point of diversion.
- 3. The referenced file number is authorized stockwatering use from one standby and three primary wells with assigned limited diversion rates and quantities all located in Section 16, Township 32 South, Range 33 West, Seward County, Kansas. The application to change the point of diversion for Water Right, File No. 28,014 received in the office of the Chief Engineer on May 30, 2017 proposes to transfer 90.587 million gallons per calendar year (278 acre-feet) and no additional rate from the well located 3,226 feet North and 3,394 feet West of the Southeast corner of Section 16 to the existing well also authorized by File No. 28,014 located 3,592 feet North and 100 feet West (g.p.s. 3,551 feet North and 111 feet West) of the Southeast corner of the aforementioned Section 16, a distance of approximately 3,299 feet. The proposed existing well will have a total of 157.043 million gallons (481.95 acre-feet) and 710 gallons per minute authorized on the well under File No. 28,014.
- 4. The proposed existing well does not meet well spacing requirements of K.A.R. 5-23-3(a)(1) to two stockwatering wells under common ownership or the requirements of K.A.R. 5-23-3(b) since the proposed transfer involves a move of approximately 3,299 feet. All wells in question are existing wells.
- 5. That in a letter dated July 13, 2017, Jason L. Norquest, Assistant Manager of Southwest Kansas Groundwater Management District No. 3, indicated that the Board of Directors of Southwest Kansas Groundwater Management District No. 3 reviewed the application, and has recommended a waiver of K.A.R. 5-23-3(a)(1) since the wells are under common ownership and serve the same stock facility as File No. 28,014. The Board also recommended a waiver of K.A.R. 5-23-3(b) since the proposal will reduce water overflow in the stock watering system and move quantity to a less pumped area. The wells involved in the transfer are authorized under the same file number so the same local source of supply will not change.
- 6. That the referenced application for File No. 28,014 should be approved with waivers of K.A.R. 5-23-3(a)(1) and K.A.R. 5-23-3(b).
- 7. That waivers of K.A.R. 5-23-3(a)(1) and K.A.R. 5-23-3(b) will neither prejudicially nor unreasonably affect the public interest and it will not impair an existing water right.

Such violation is a class C misdemeanor, punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. K.S.A. 82a-728(b). Civil penalties shall be not less than \$100 nor more than \$1,000 per violation. In the case of a continuing violation, each day such violation continues may be deemed a separate violation. In addition to these penalties the water right may be modified or suspended. K.S.A. 82a-737, as amended.





This is to advise you that your application for approval of the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, to change the allocation between points of diversion under the above referenced application requires a waiver of a rule, specifically, K.A.R. 5-23-3 as it pertains to distance moved further than a half mile and short on minimum spacing to wells, also owned by the applicant.

The application proposes to move 277.5 acre feet of authority to a well described as being 3592 feet North and 100 feet West of the SE corner of Section 16, Township 32s, Range 33w, in seward County. A plat and groundwater resource review information is enclosed for your reference.

Changing a water right in a local aquifer area can affect the water supply to the project and to other water rights and users. Kansas law (K.S.A. 82a-708b (2)) requires a demonstration that any change is reasonable and will not impair existing rights. Spacing rules provide a standard for implementing this requirement. Conversely, not meeting the spacing standard creates a presumption that impairment will occur

To meet the need for added due process beyond the ½ mile courtesy notice from the state, the GMD3 Board passed Resolution 2013-6, adopted December 17, 2013. This resolution established a process of seeking more information from you and the neighboring water right owners whose wells are located within a mile of a proposed location requiring a rule waiver.

Accordingly, local resource information is included with this letter and you are requested to provide information in response to the following questions:

- 1) Can the aquifer yield a similar water supply at both the present well location and at the proposed well location(s)? In other words, how might the well yield differ in the proposed location from the present location?
- 2) Can the addition of infrastructure, such as pipelines or purchase of neighboring wells with water rights, meet the need without a rule waiver?
- 3) How do the specifics of the proposal conserve energy and/or water over other alternatives?

The GMD3 board supports the pursuit of high value water use, through reasonable changes that don't have an unreasonable affect to other water rights. We request that any response you or your neighbors wish to provide should occur within 15 days from the date of this letter or any extension of

We would like to request a transfer of 277.5 acre-ft from 3300N 3300W 16-32S-33W to 2592N 100W 16-32S-33W. These two water wells are in the same water right file No. 28014 and we can control the usage better with the later well.

The water well on 3300N 3300W 16-32S-33W pumps water with a natural gas engine, which will not allow us to control the water pressure in our lines.

The water well on 2592N 100W 16-32S-33W uses an electric motor with VFD. The electric motor will allow us to control the water pressure in the lines. If the water pressure goes down, it will increase the gpm; and if it goes up, the gpm decreases. Keeping the correct pressure in the lines also reduces the problems with our water tanks, while maintaining less overflow water in our drain lines.






