Dear Mr. Barfield:

Th enclosed change application and associated documentation along with a check for the applications fees are submitted for your review and approval. I have entered into an agreement with HRC Feed Yards, L.L.C. to sell them 30 acre-feet of water associated with File No. 11,385, which is a water right owned by me. This water would be used for stockwatering purposes at a feed yard located adjacent to the place of use associated with File No. 11,385. We propose to use the additional well regulation to move a quantity of 30 acre-feet (AF) and rate of 23 gallons per minute (gpm) to an existing well associated with File No. 34,127 (ID 7). This well is located within the adjacent feed yard and is owned by HRC Feed Yards, L.L.C.

The provisions of K.A.R. 5-5-9 and 5-5-10 were used to determine the consumptive use quantity associated with File No. 11,385. We propose an authorization of 30 AF for stockwatering use and 224.326 AF for irrigation use. This results in a reduction of 6.67 AF from the currently authorized quantity of 231 AF. The proposed change will therefore not increase consumptive use. The irrigated acres were reduced in proportion with the quantity reduction, from 127 acres currently authorized for irrigation to 105.5 acres.

A flow rate test was conducted on the well associated with File No. 11,385 on April 11, 2018. The measured rate was 490 gpm. After the proposed rate for stockwatering use is deducted from the measured rate of 490 gpm, the remaining rate will be sufficient for irrigation purposes.

We searched for neighboring wells within ½ mile of the currently authorized and proposed additional wells associated with File No. 11,385. The closest wells are the two authorized under File No. 34,127, which are owned by HRC Feed Yards, L.L.C. An irrigation well associated with File No. 15,649 located in Section 34 T18S R33W was also identified. This well is more than ½ mile from the proposed additional well but less than ½ mile from the currently authorized well. A review of information on the WIMAS database indicated

that there has been no water use reported for this well from 2012 through 2016. There may be a domestic well in the NE ¼ of Section 34 T18S R33W. We could not determine if this well is in use. It appears that this well is more than 660 feet from any of the wells associated with this change application. Both of the wells in Section 34 are owned by the same person.

It appears that two waiver requests are needed for approval of this application. I request a waiver of K.A.R. 5-21-7. It is my understanding that Groundwater Management District No. 1 (GMD 1) has requested that this regulation be revoked so that the provisions of K.A.R. 5-5-9 and 5-5-10 can be used in its place. Since the revocation process has not yet been completed, a waiver of K.A.R. 5-21-7 is needed so that the consumptive use calculations can be approved.

I also request a waiver of K.A.R. 5-21-3, which relates to well spacing. The proposed additional well does not alter any of the existing well spacings, which were previously approved. The proposed changes reduce the rate and quantity in proximity to File No. 15,649, which is the closest neighboring well that is not a party to this change application. The proposed changes provide benefits to the owners of File No. 34,127, the closest neighboring wells. This application was presented at the March board meeting of GMD 1 and the board supported approval of this waiver. It appears that there is sufficient justification for this waiver.

Once approved, compliance with the terms, conditions and limitations of the permit is necessary. Conservation of the water resources of Kansas is required.

Section 82a-728 of the Kansas Water Appropriation Act, provides (a) except for the appropriation of water for the purpose of domestic use, . . . it shall be unlawful for any person to appropriate or threaten to appropriate water from any source without first applying for and obtaining a permit to appropriate water in accordance with the provisions of the Water Appropriation Act or for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.

(b) (1) The violation of any provision of this section by any person is a class C misdemeanor... A class C misdemeanor is punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. Each day that the violation occurs constitutes a separate offense.






