Kay Berghaus, Trustee, of the Dean Berghaus Living Trust and Kay Berghaus Living Trust, along with Marc and Jeanne Berghaus, Tereda Cook and Charles Jeffery Twist as owners submitted applications on September 24, 2018, to change the irrigated place of use. The signature of Charles Jeffery Twist was determined to be on behalf of Twist Family Farms, LLC per the documents submitted and Meade County register of Deeds. While the Twist signature of does not appear to be needed after the division of File No. 13,158, resulting in their portion to be held separately under 13,158-D2, a portion of Section 30 is also authorized by File Nos. 3,149 and 28,580.

The referenced water rights appear to be in compliance with K.S.A. 82a-732 and the applications comply with K.A.R. 5-5-2a, with the updates to the ownership and addresses supplied by the applicants.

The referenced files are authorized separate portions with several complete and incomplete overlaps in place of use with a total of 1,473.51 acres authorized. The only additional limitation is on the rate of diversion under File No. 13,158-D1 that the rate is limited to 1,190 gallons per minute with File No. 3,149. Originally the apps proposed a total of 1,475.51 acres to be irrigated eliminating all incomplete overlaps, but with no acres that had not been authorized, but didn't take into account the base acres. The place of use will remain within what is currently authorize but eliminating the incomplete overlaps as there is no justification of K.A.R. 5-3-5n, *Authorized place of use*. Additionally, the division of File No. 13,185, will also eliminate a large incomplete overlap, allowing these separate owners to operate independently. The applications required a modification due to the referenced files base acres totaling 1,224.5 acres. A review of the base acres by Mike Meyer, Water Commissioner, Garden City Field Office determined 1,224.5 acres under File Nos. 3,149; 9,982; 13,158-D1; 14,309; 25,031; 28,580 & 30,950. As allowed per K.A.R. 5-5-11(b)(1), each right base acres can be increased ten acres or ten percent whichever is less as allowed. As four different base acres were developed that would allow ten acres to be added each was afforded its ten acres or a total of 1,264.5 acres to be proposed by the complete overlap of the referenced files.

The November 27, 2018, modifications to the applications by Kay Berghaus will propose a total of 1,264.02 acres authorized complying with of K.A.R. 5-5-11, *Applications for change in place of use for irrigation purposes*. No increase in the consumptive should occur thus complying with K.A.R. 5-5-3, *Change in consumptive use*.


Historically the 1,473.51 acres developed an irrigation ration of 1.88 acre-foot per acre with the 2,778 acre-feet authorized by the referenced files. The change will result in the in an irrigation ratio of 2.20 acre-foot per acre. This exceeds the standard 2.00 acre-foot per acre as allowed by K.A.R. 5-3-23, *Maximum reasonable annual quantity approvable for irrigation use for an application for change in place of use and a request to reduce a water right*. To allow flexibility an additional limitation will be placed on File Nos. 25,031; 28,580 and 30,950 limiting the 2,778 acre-feet authorized to a maximum annual quantity of 2,528.04 acre-feet when combined with the senior files.

In a letter dated October 25, 2018, Jason Norquest, Assistant Manager, Southwest Kansas Groundwater Management District No. 3, recommend approval of the applications, if they complied with K.A.R. 5-5-11.

Michael Meyer, Water Commissioner of the Garden City Field Office area reviewed the proposed applications. In an email dated December 3, 2018, he recommended approval of the change applications.

Water flowmeters will be required for the change approvals. The water use correspondent will be updated to Kay Berghaus Living Trust for all of the referenced files. A check valve will be required, if chemigating. As no new wells will be drilled a water level measurement tube and WWC-5 will not be a condition of the approvals.

Based on the above discussion, that the change to the place of use authorized by all of the referenced files will make a complete overlap and not substantially increase the acres above what is currently authorized and with no increase in the historical consumptive use, it is recommended that the referenced applications be approved.



All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 14,309, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated February 16, 2000, as modified and amended by the aforementioned order.

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., **within a total of 18 days after this Order was mailed to you**), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., **within a total of 33 days after this Order was mailed to you**), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.

Change PU (complete overlap) and Division


