

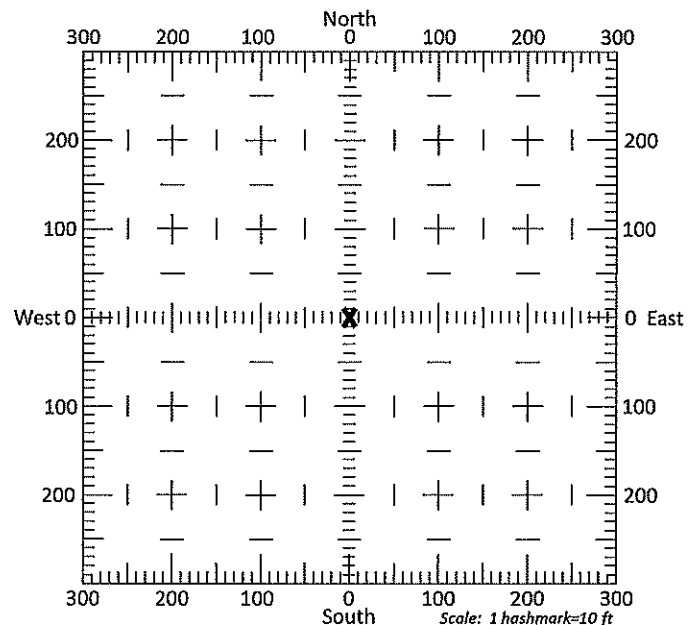

SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, et seq. and other applicable provisions of the *Kansas Water Appropriation Law, K.S.A. 82a-701 et seq.*, and rules and regulations promulgated thereunder. With the exception of those conditions expressly contained herein, this Summary Order does not change the terms, conditions and limitations of File No. 26527.

- 1. A change application was received on April 30, 2018 requesting that the place of use and / or point of diversion authorized under the above-referenced file number be changed as described in the application.

Failure to timely request a hearing or review may preclude review under the Kansas Judicial Review Act.

The Love Ag has applied to alter the acres authorized to add a pivot location. The base acres are 1496. There are no neighboring wells within ½ mile.

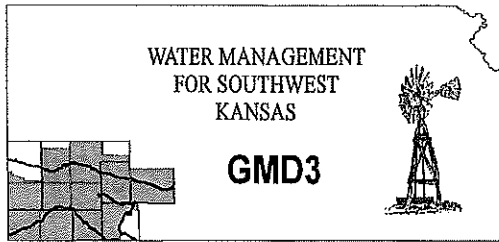


