Applications to change the authorized point of diversion have been filed under the above referenced water rights. The applications to change the point of diversion under File Nos. 3,493 and 9,249 propose to return to an existing well previously authorized by these water rights. While the change to File No. 21,107 proposes to drill a new well.

The change to File Nos. 3,493 and 9,249 are intended to return to a well that was previously authorized but revoked by order of the Chief Engineer dated March 9, 2018. The change in point of diversion dated January 15, 2013, had authorized the proposed points of diversion, however, it was discovered that the application to change the point of diversion had not been signed by all landowners. The proposed applications to change the point of diversion have now been signed by all landowners and the applicant can proceed with drilling a new well under File No. 21,107 and can now legally appropriate water from the existing completed wells.

There are no other wells of any kind located within one half mile of the proposed wells. Therefore, no notifications were sent.

The source of supply for the existing well and well proposed under 21,107, appears to be the Ogallala formation, there should be no change in the local source of supply.

In an letter dated June 19, 2018, Jason L. Norquest, Assistant Manager, GMD 3, recommended approval of the applications.

In an e-mail dated June 25, 2017, Mike Meyer, Water Commissioner of the Garden City Field Office, recommended approval of the applications.

A water flow meter will be required on each point of diversion. A check valve will be required if any chemical or foreign substance is injected into the water through the diversion works:

Based on the above discussion, that the change is reasonable, that impairment to existing water rights is unlikely, that no change in the local source of supply will occur, it is recommended that the referenced applications be approved.



The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Kyle and Heidi Simmons, Rick and Kathryn Redd on behalf of Reddhawk, LLC, PO Box 296, Sublette, Kansas 67877, and David J. Dietz, PO Box 296, Sublette, Kansas 67877, T Brian Eilerts, 2023 N. Chipmunk Ct, Flagstaff, Arizona 86004, and Zane B. Eilerts, 8155 Silkwood, Huntington Beach, California 91464, received in this office on April 10, 2018, for approval of a change in the location of the point of diversion under the certificate of appropriation issued pursuant to the application for permit to appropriate water for beneficial use, finds that the change is reasonable and will not impair existing rights and that the application should be and is hereby approved.

The effective date of the changes shall be the date this order is executed by the Chief Engineer, after which the points of diversion shall be described as being:

one (1) well located in the Northwest Quarter of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 8, more particularly described as being located near a point 2,019 feet North and 2,518 feet West of the Southeast corner of said Section, Township 30 South, Range 32 West, Haskell County, Kansas,

located substantially as shown on the topographic map accompanying the application to change the place of use.

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

Installation of the works for diversion of water shall be completed on or before December 31, 2018, or within any authorized extension of time. The applicant shall notify the Chief Engineer of the Division of Water Resources, Kansas Department of Agriculture, when construction of the works for diversion has been completed.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 27,107, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated May 26, 1994, and as modified and amended by the aforementioned orders.

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., **within a total of 18 days after this Order was mailed to you**), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., **within a total of 33 days after this Order was mailed to you**), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.

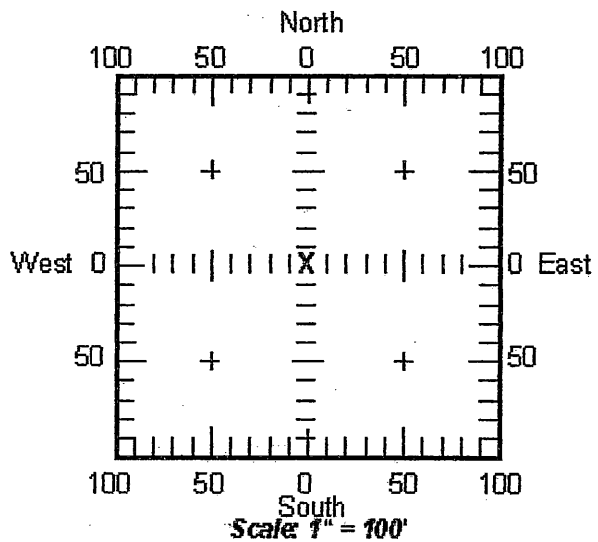

All wells within 1/2 mile have been plotted

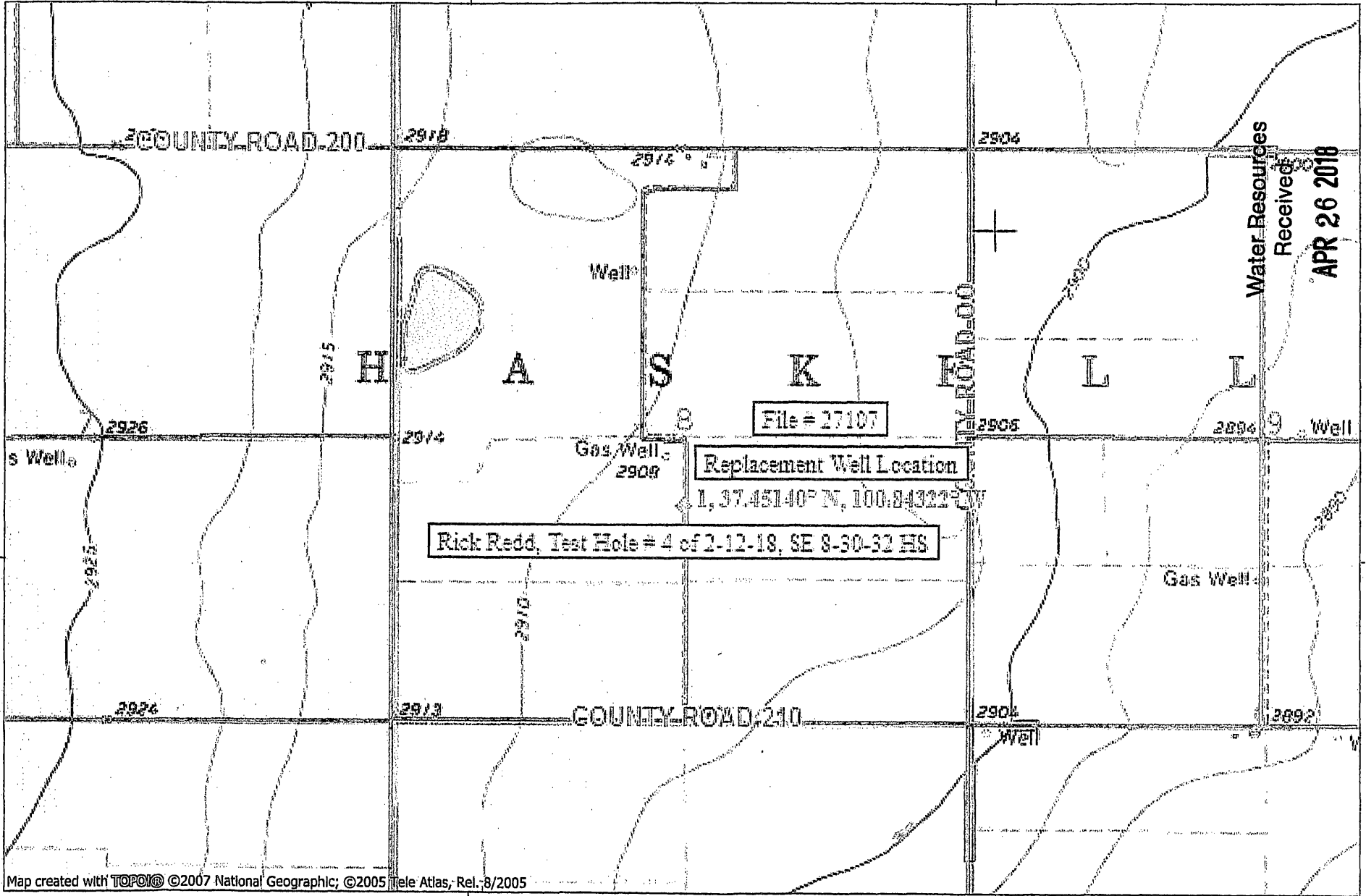

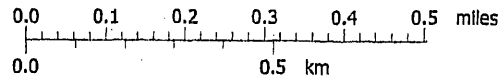

Mr. Michael Meyer,

It has been brought to my attention that Mr. Rick Redd is attempting to file paperwork with your office regarding a re-drill and a diversion of water to the (re-drill) new well on 30-32-8 Haskell County, Kansas. As I informed you in an email, in a timely manner prior to the filing of these documents, my signature was revoked authorizing a re-drill and relocation of diversion.

My signature on these documents was predicated on an agreement that Mr. Redd would purchase 40 acres of property from me, my remaining water rights on 30-32-8, and my half interest of irrigation motors on both 30-32-17 and 30-32-8. As I had every intention of selling the 40 acres of land I would no longer have use for the remaining water rights on section 8, or the half interest in motors on section 8 and section 17.

I was presented with three separate signature pages only, with no legal body or description of activity that would take place, just the page where my signature was presented to me. I was told that it was the same document that was sent to me via mail and that I still have on file in my office to this day and that the extra signature pages were for copy purposes only and in no way had the legal body and issues addressed in these documents changed in any way from the original form sent to me in the mail by Mr. Redd.

Mr. Redd did not enter good faith negotiations to purchase the 40 acres of land or the remaining water rights on section 8. As Mr. Redd refused to enter into good faith negotiations, I immediately emailed the division of water resources, contacting you, and revoked my signature long before the diversion and re-drill documents were filed in your office.

I have been informed that there are three (3) different documents and water files being effected by Mr. Redd's attempted filings. I have no knowledge of these three files or what these documents being filed contain.

Mr. Redd has filed fraudulent documents with your office in the past with regards to my Mothers signature on water right document number 9,249. My mother did not own the minerals, nor the land,

at the time her signature was applied. Furthermore, Mr Redd claims no knowledge that Zane B Eilerts and I owned these rights at the time of my mothers' signature. This is an untrue statement by Mr. Redd. Rick Redd was aware of the transfer of land to myself and Zane B Eilerts in a warranty deed dated November 3, 2003. Performing due diligence was also the responsibility of Mr. Redd at the time these documents were signed by my mother and Mr. Redd failed to do so. My complaint filed for the filing on water right 9,249 was upheld and made null and void by the division of water resources as stated in a letter from the board dated March 12, 2018. As the proof showed Mr. Redd is known to file documents with your office that are not completed correctly and give economic benefit to himself.

I strongly urge you to error on the side of caution when making your decision. Mr. Redd has been known to file fraudulent and incomplete documents with the division of water resource offices. I am only aware of a single document that would have been filed in this case on which my signature was revoked in a timely manner prior to Mr. Redd filing. I have every right to read and inspect every document being filed prior to a valid signature being applied by my hand. Mr. Redd misrepresented his intentions with three separate signature sheets constituting fraud. My signature was revoked because Mr. Redd failed to complete the predetermined terms to my signature appearing on these documents. Furthermore, granting Mr. Redd the permissions and provisions that these documents must contain will give Mr. Redd an unfair economic advantage, render my remaining land and water resources valueless, and grant Mr. Redd the right to change water rights that were not discussed or agreed to.

I pray you deny Mr. Redds' latest filings with the division of water resources.

Reference is made to your applications for approval of the Chief Engineer to change the point of diversion under the referenced file numbers which were received in this office on April 10, 2018. Upon review of the applications and additional information received by this office, it is found that the applications to change the point of diversion cannot be approved as proposed.

In a letter dated April 10, 2018, received in the office of the Chief Engineer on April 16, 2018, T Brian Eilerts has requested that his signatures be removed from the applications.

Please note that K.A.R. 5-5-5 states in part:

"If more than one person is the owner of a water right, and an application is filed for a change in the place of use, point of diversion, use made of the water, or any combination thereof, only the signature(s) of the landowner(s) whose portion of the water right(s) is (are) involved in the change shall be required on the application. If the extent of each owners interest in the water right has not been legally determined, then all landowners holding an undetermined portion of the water right must sign the change application . . . "

Based on the request by Mr. Ellerts above, the applications no longer contain the signatures of all landowners and spouses associated with the currently authorized place of use, therefore, the applications cannot be approved as filed.

For the reason given above, it will be recommended to the Chief Engineer that the Applications for Approval to Change the Authorized Point of Diversion and place of use under Water Right, File Nos. 3,493, 9,249 and 27,107 be denied and dismissed for failure to comply with K.A.R. 5-5-5.


