

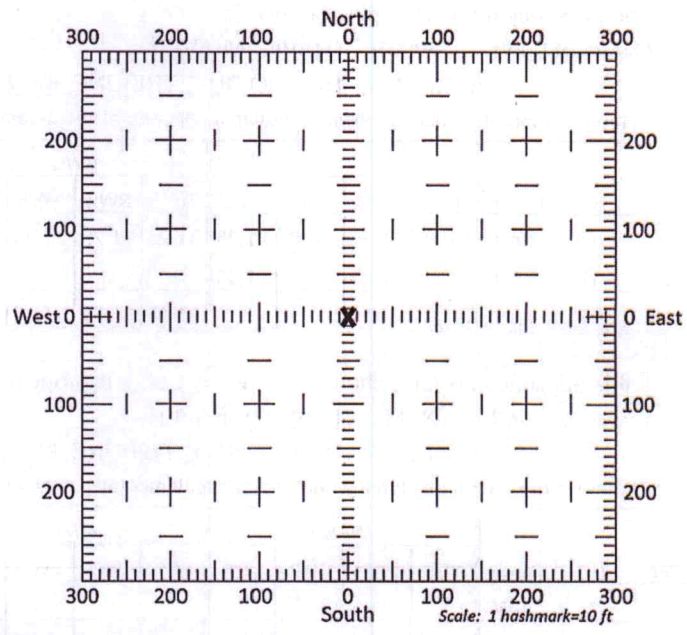

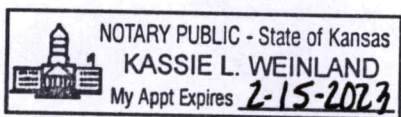

Failure to timely request a hearing or review may preclude review under the Kansas Judicial Review Act.

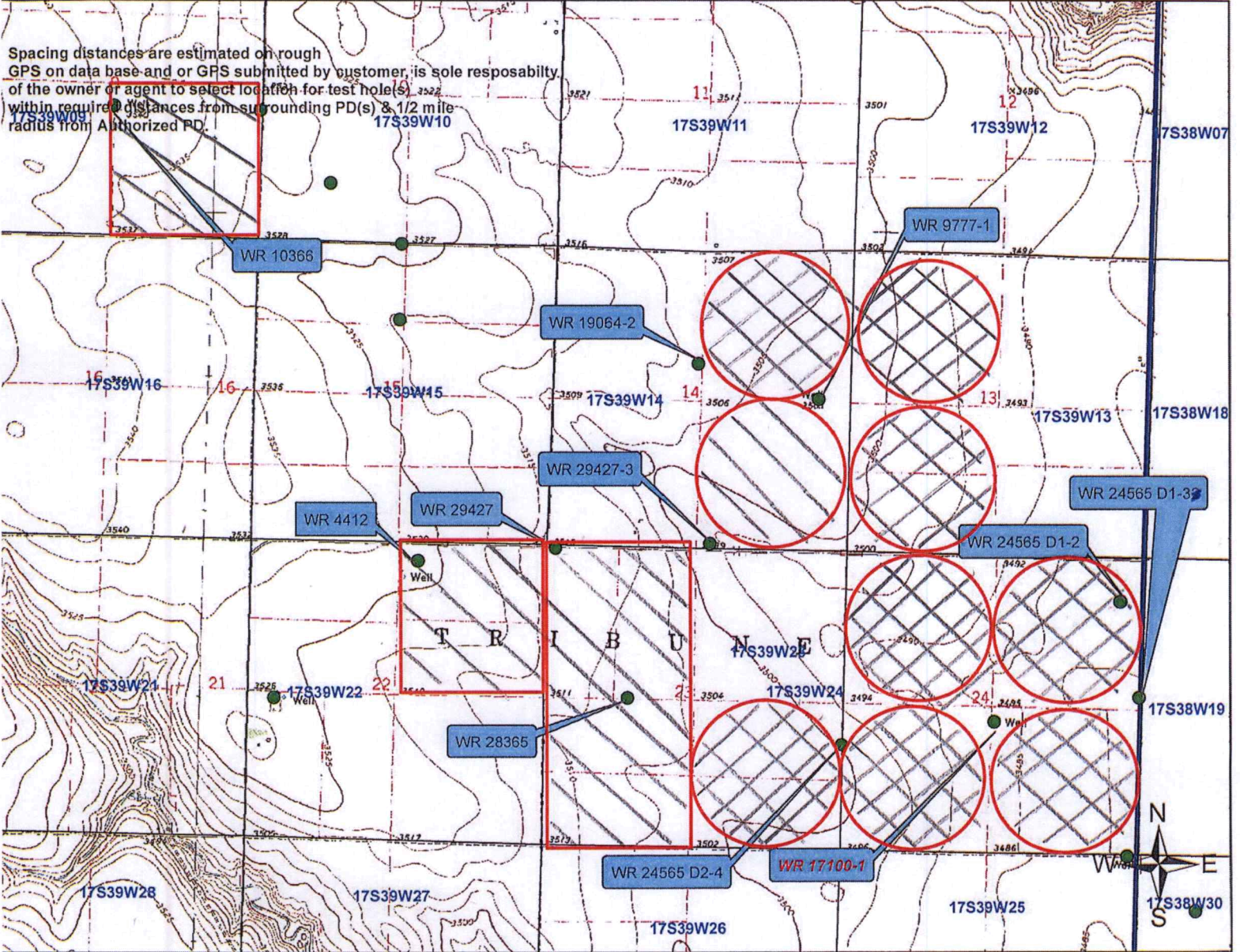


