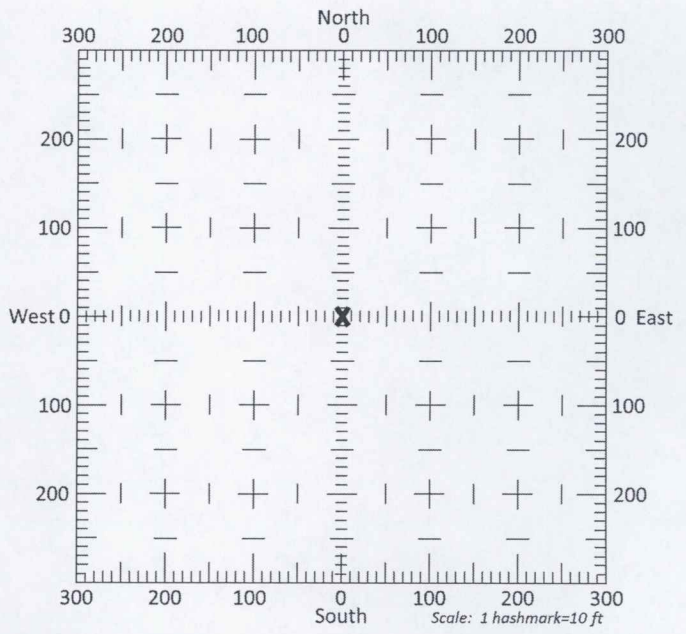

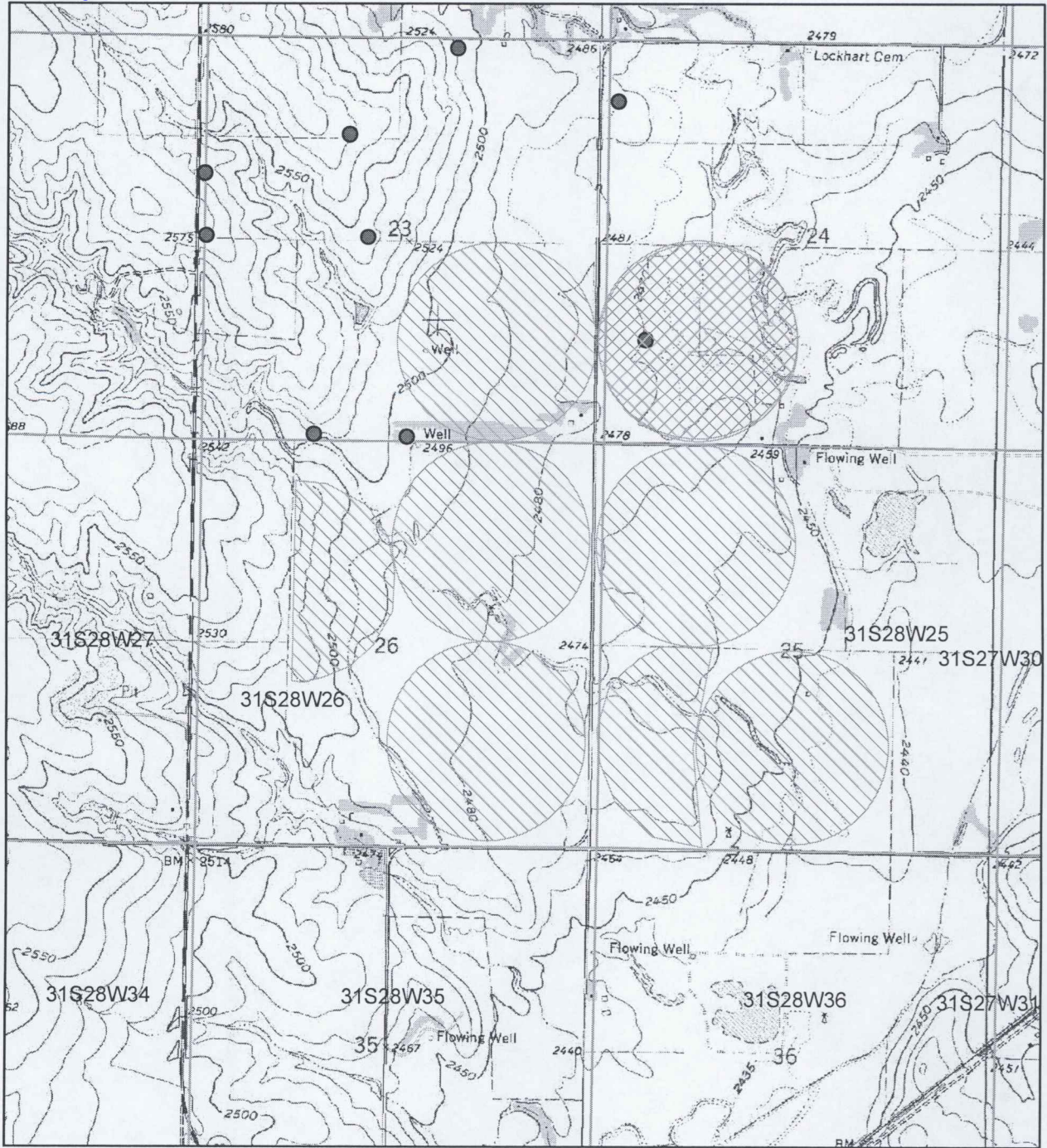

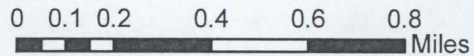

Field office change applications of the above referenced files are being sent to headquarters for further processing. The original applications were received to make a complete overlap between all files that met base acres review. (adding new land but meets K.A.R. 5-5-11) One owner, Hildebrand did not sign. After much process, the Batman's decided to dismiss File Nos. 21411 and 24355 that involved the Hildebrand ground due to lack of agreements and signatures and modified the original remaining applications to make a complete overlap and meet base acres. These applications need processed due to the dismissal applications requests and further processing

For the record, Base acres are:

File No. 264 = 730 acres and 268 perfected acres

File No. 18379 = 730 base acres (same as File No. 264) with no additional base and 399 additional perfected acres

File No. 21411 = 120 base acres and 120 perfected acres

File No. 24355 = 130 total base acres (120 pivot area (same as File No. 21411) and 20 flood acres). Total combined base acres for File No. 21411 and 24355 are a total of 130 acres firm. Perfected acres for File No. 24355 are only 40 acres max. (also see attached aerial photo)
