



We have completed a review of the application for the above referenced water right. The proposed change in point of diversion is in accordance with current area rules, K.A.R. 5-23-3, as it pertains to distance moved and minimum spacing to neighboring wells.

Well evaluations were conducted to estimate possible effects of the proposal on the supply of other wells with water rights prior to the proposal per K.S.A. 82a-708b, and the draft revised management program. Under K.S.A. 82a-708b, an applicant requesting a change in point of diversion must demonstrate to the chief engineer that any proposed change is reasonable and will not impair. The analysis was more difficult for this area. All wells would be noted as critical. However, the modeling in this area may not always consider the full extent of the aquifer. New updates are hoping to be completed in the near future.

The applicant owners most of the wells in the area, except for one irrigation well and a battery of stock wells, which are owned/operated by one other entity. We contact that neighbor for their perspective on the proposed change. They noted that the applicant is moving further away from their wells and do realize the hydrology for the area. They believe the application should not be hindered and did not want to state any concern for the move, but support. Therefore, GMD3 sees this move as reasonable and therefore recommend that the application be approved. If aquifer conditions change or there is a change to the water right in the future, we would be happy to evaluate the effects at that time.
