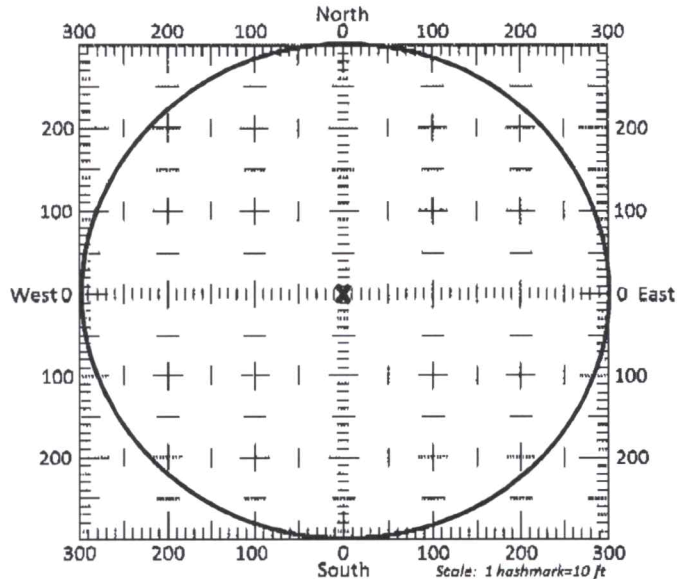

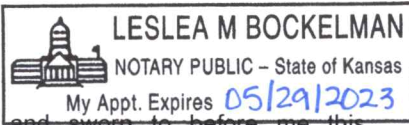

**SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS**

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, *et seq.* and other applicable provisions of the *Kansas Water Appropriation Law, K.S.A. 82a-701 et. seq.*, and rules and regulations promulgated thereunder. With the exception of those conditions expressly contained herein, this Summary Order does not change the terms, conditions and limitations of File No. 189.

1. A change application was received on May 13, 2021 requesting that the place of use and / or point of diversion authorized under the above-referenced file number be changed as described in the application.

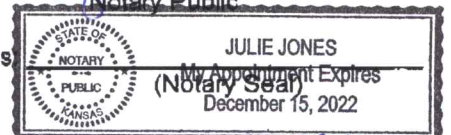
**Administrative Appeal and Effective Date of Order**

Failure to timely request a hearing or review may preclude review under the Kansas Judicial Review Act.

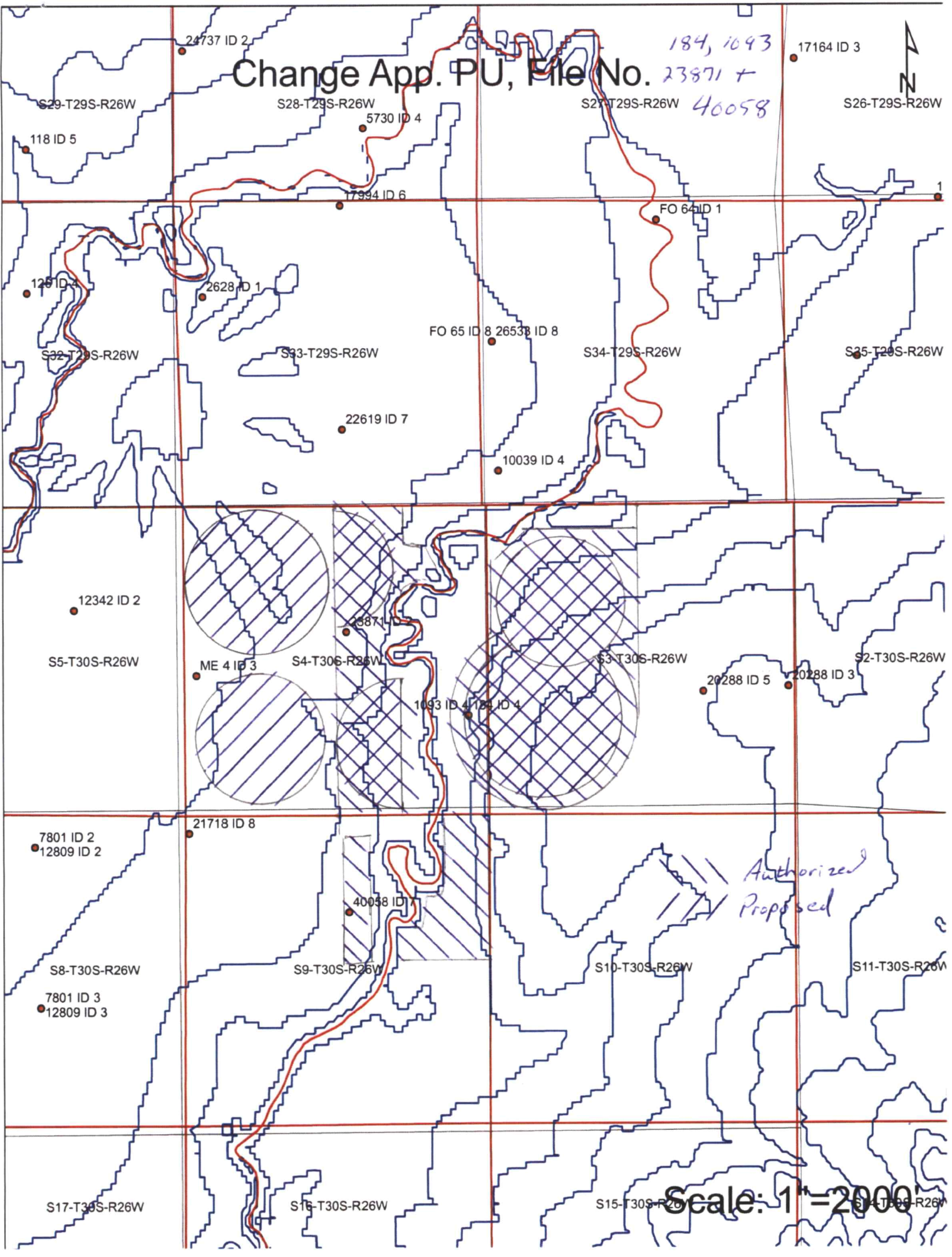

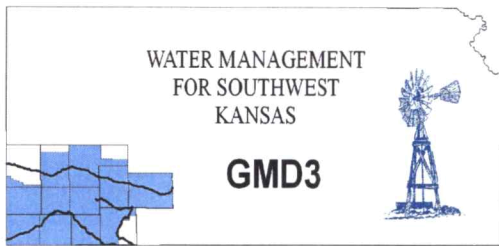


