The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of W R Renick Inc., 6514 U.S. Highway 50, Garden City, Kansas 67846, received in the office of the Chief Engineer on April 9, 2021, for approval of a change in the location of the place of use under the certificate of appropriation issued pursuant to the permit to appropriate water for beneficial use, finds that the change is reasonable and will not impair existing rights, and that the application should be and is hereby approved.

This order effectively reduces the authorized quantity of water not to exceed 390 acre-feet per calendar year.

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the authorized location of the place of use shall be:

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year

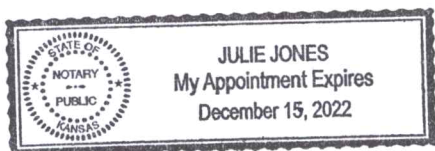

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.

Any request for hearing or petition for administrative review shall be in writing and shall be submitted to the attention of: Chief Legal Counsel, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, Fax: (785) 564 - 6777.



Applications to Change the Place of Use to separate the ownership interested between WR Renick and Huber Sand. This process could have been done also with requests to reduce a portion of an existing water right, but staff at GMD3 elected to use change applications as they assisted the applicant. GMD3 also recommend approval of these applications. These files were originally incompletely overlapped in place of use, but majority was completely overlapped.

The total authorized acres and quantity combined prior to these applications were 1027.88 acres and 2260 acre feet. With the separation of interested, the following will be authorized:

WR Renick, File Nos. GY 024, 3563, 19001, 22414 will be authorized a total of 657 acres (increase in base acres by no more than 10 acres) and a total of 1642 AF as his previous water rights were already authorized at 2.5 acre feet per acre, he requested to keep that acre feet per acre ratio. In fact, he voluntarily reduced his authorized quantity under File No. 19,001 from 436 acre feet to 390 acre feet in order not to exceed the total authorized quantity of the 2.5 acre feet per acre or 1642 acre feet.

Huber Sand, File Nos. FI 014, 8627, 11215 will be authorized a total of 369.88 acres and a total of 572 acre feet, or 1.54 acre feet per acre, which is reasonable on all standards. No reduced quantity or acres took place with the request.

The authorized acres were adjusted to be property described in the River Lots and Arkansas River boundary described in the Kansas Land Survey Plat Maps document in the late 1880s that are on file with the Division. WRIS database will properly show acres described as acres within the Arkansas River Stateland & Water person id. No new acres were approved within this boundary.

These requests are reasonable and recommend approval of the applications.

I spoke with David this morning, I told him I would relay the same information to you for you all to talk and understand what we further need to process these applications to separate from Huber etc.

today, David has 2.5 AF per acre on his section 20 wells. (1000 AF on 400 acres)
the other ground on 18, 19, and hubers combined has 2.0 AF per acre (1260 AF on 627.88 acres...

with the applications filed, and combining section 18 and 19 with section 20 for David, those wells all added together for those acres would give him over 2.6 AF per acre (1688 AF on 647 acres)

we cant allow that as we just now increased his overall water rights.

what we need to do is reduce 71 AF off of the proposal of his wells to end up with 1617 AF o n 647 acres , thus 2.5 AF / acre.

I suggested to him we don't touch section 20 wells/ water rights as they are vested and senior

I recommended to him to reduce the well on section 19 from 436 AF to 365 AF

but however he wishes to remove 71 AF overall, it doesn't matter to us, but the reduction would need to take place

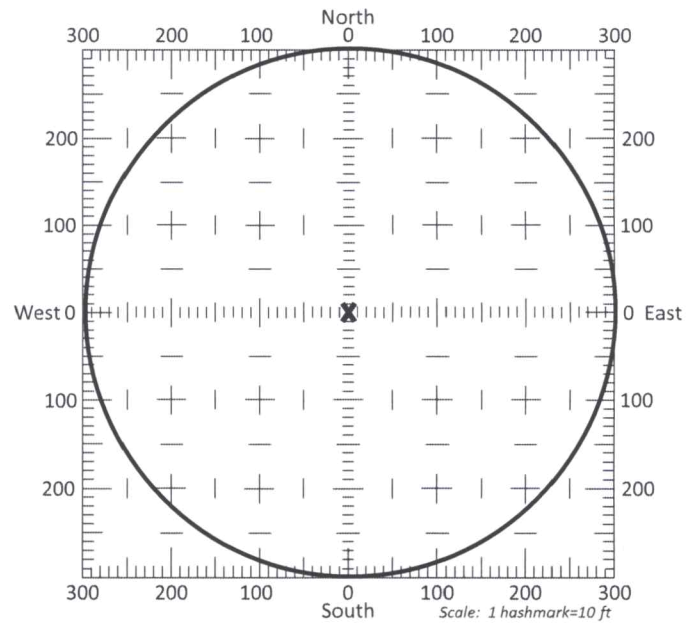
