



Dear Mike:

We have completed a review of the applications for the above referenced water rights. The proposed change in authority between the points of diversion is in accordance with current area rules, K.A.R. 5-23-3, as it pertains to distance moved and minimum spacing to neighboring wells. The move to the north well will increase the authority from that point of diversion, while the south well is proposed to have less authority than it's recent average reported use.

Well evaluations were conducted again to estimate possible effects of the proposal on the supply of other wells with water rights prior to the proposal per K.S.A. 82a-708b, and the draft revised management program. Under K.S.A. 82a-708b, an applicant requesting a change in point of diversion must demonstrate to the chief engineer that any proposed change is reasonable and will not impair. The enclosed report is an analysis performed by the GMD on behalf of our membership. Under this analysis, the proposed change is considered to be reasonable and unlikely to impair if either the net in-season well-to-well effect of the proposed change is less than a strict maximum allowable threshold (4.0 ft in cases where saturated thickness is greater than 200 ft), or if no well with a net well-to-well effect exceeding the threshold is identified as critical. Critical wells are identified as wells that are expected to either lose or greatly diminish water supply over the next 25 years. The attached review information is based on a Theis analysis using inputs from the GMD3 aquifer model, which is considered to be the best information on well and aquifer data readily and easily available to the public. If either the applicant or the neighbors believe they have better data that might change the result of the analysis, they should contact GMD3. Conclusions of the well analysis may change if better information on well and aquifer data can be made available.

Every neighboring well within 1 mile of the proposed move was evaluated. Evaluations showed one of the neighboring wells, which is under the same ownership, exceeded the net effect above the maximum allowable threshold and required further evaluations. Further analysis showed that the proposed new authority would not be considered critical. Therefore, GMD3 sees this move as reasonable and therefore recommend that the application be approved. If aquifer conditions change or there is a change to the water right in the future, we would be happy to evaluate the effects at that time.



Is a waiver needed: The flip in authority is less than half mile and minimum spacing to neighboring wells is met. The move to the north well will have increased authority on the well. The only wells in the area are the applicant's. The first guidelines are exceeded on WR261, but further evaluation showed that the well would not be critical. The change in authority on the south well will decrease the authority on the well to an amount that is less than the prior average use reported and should not cause possible impairment. Recommendation: Seeing as how this move will send more authority to a well surrounded by the applicant's other wells, analysis shows it not to be critical. The other move will reduce authority in the area. All other current area rules are met. Staff therefore recommends approval of the application.

Evaluation of proposed move for Water Right Nos. 435, 38616, 40062, and 41347

Proposed: Move water right no. 435 to the well currently authorized under water right nos. 38616, 40062, and 41347, a distance of 2,332 ft to the southwest. Move water right nos. 38616, 40062, and 41347 to the well currently authorized under water right no. 435, a distance of 2,332 ft to the northeast. Total authority on the southwest well will be reduced from 1453AF @ 1800 gpm to 640 AF @ 1000 gpm. Total authority on the northeast well will be increased from 640 AF @ 1000 gpm to 1453 AF @ 1800 gpm.

Drawdown from current location = 9.34 ft

Drawdown from proposed location = 13.86 ft

Net drawdown = 4.5 ft

Drawdown from current location = 14.81 ft

Drawdown from proposed location = 18.00 ft

Net drawdown = 3.2 ft

Net drawdown exceeds the drawdown allowance of 4.0 ft for the well authorized under water right no. 261. Critical well analysis is necessary on that well.

Critical Well Evaluation:

261:

Water Column = 226 ft

DP = 4.5 ft (Net drawdown from the proposal indicated above)

DE = 24.2 ft (Water level decline from 2021 through 2046 based upon GMD3 model)

DD = 10.5 ft (S = 0.05629, T = 83,808 gpd/ft, Q = 300 gpm, tp = 127 days, efficiency = 70%)

DT = 39.2 ft

Economic Drawdown Constraint (EDC) = 0.4 * 226 ft = 90.4 ft

Physical Drawdown Constraint (PDC) = 226 ft – 60 ft = 166 ft

Total drawdown of 39.2 ft is less than the EDC and PDC, so this well is not critical.


Conclusion:

The proposed moves will create an effect on the well authorized under water right no. 261 that is likely to be noticeable. Saturated thickness, modeled declines, and aquifer parameters show that this water right will likely be able to access a similar rate and quantity to its current use over the next 25 years, accounting for the move. This well is also owned and operated by the Applicant. Therefore, GMD3 staff recommends approval of the application.


