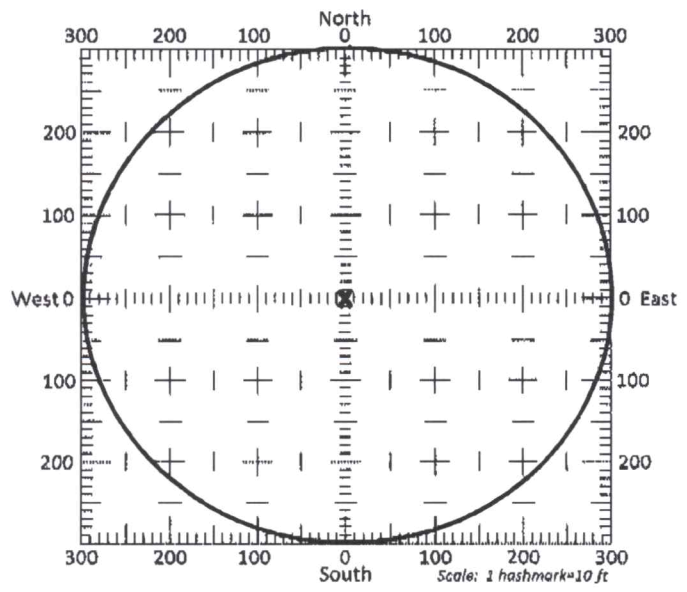

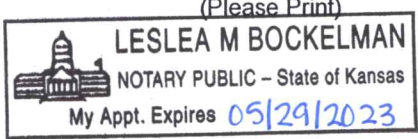

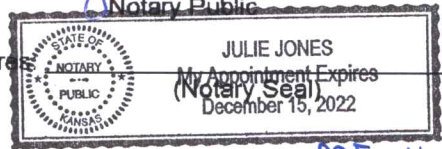
Administrative Appeal and Effective Date of Order

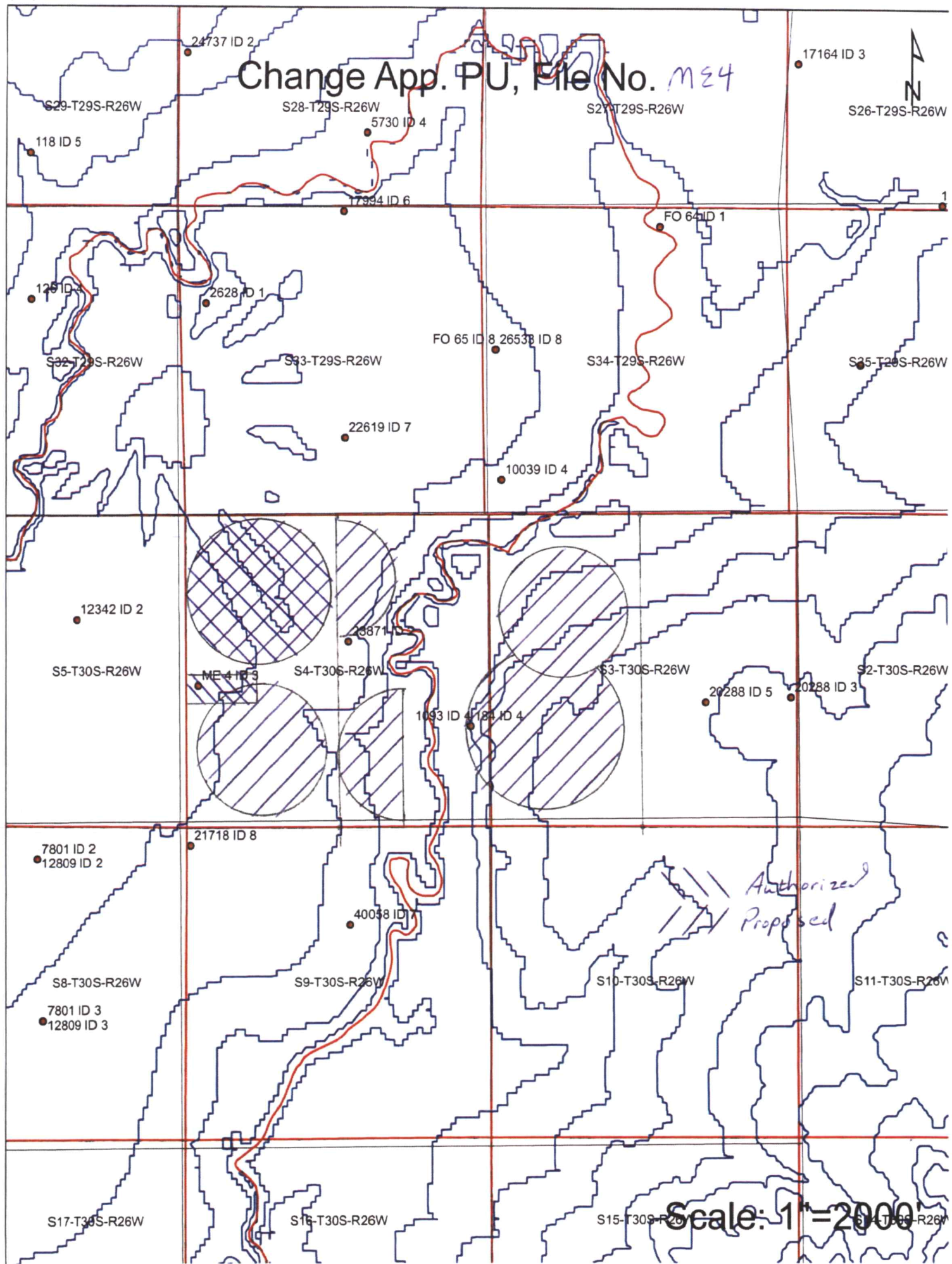

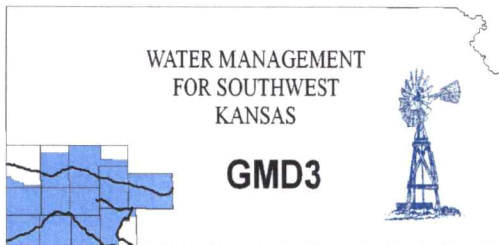
