- Proposed point of diversion

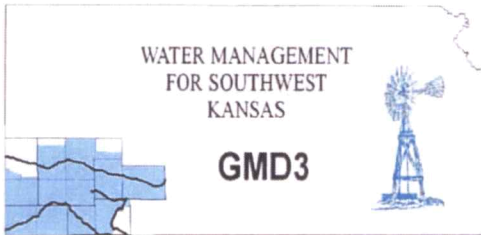


All wells within 1/2 mile are on this map.



This is to advise you that the Forest Service filed an application for approval of the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, to change the point of diversion. The applications meet all rules and regulations.
