Enclosed are the orders executed by the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, approving the applications for change under the above referenced files.

Your attention is directed to the enclosures and the terms, conditions, and limitations specified in the approvals. A condition of each approval is that an acceptable water flow meter must be installed on the diversion works authorized.

Approval of the applications does not allow the diversion of water in excess of the authorized quantity per calendar year or rate of diversion under the above referenced file numbers, even though the authorized place of use has been increased. Your attention should be directed to the fact that the approvals have been issued solely for the purpose of allowing rotation of the irrigated land within the authorized place of use, with no more than the base acreage, 410 acres for the referenced files under irrigation in any one calendar year. Non-compliance with the terms of this approval will result in substantial penalties.

Please be reminded that File No. 41,725, remains limited to a diversion rate of 990 gallons per minute and 728 acre-feet per calendar year with File No. 41,456.

Since these orders modify the original documents referred to above, they should be recorded with the Register of Deeds as other instruments affecting real estate.





Only 410 acres can be watered in a calendar year. All aspects of the original approval for a monitoring rotation shall remain in place in accordance with K.A.R. 5-5-11(b). It is therefore recommended that the applications be approved at this time.
