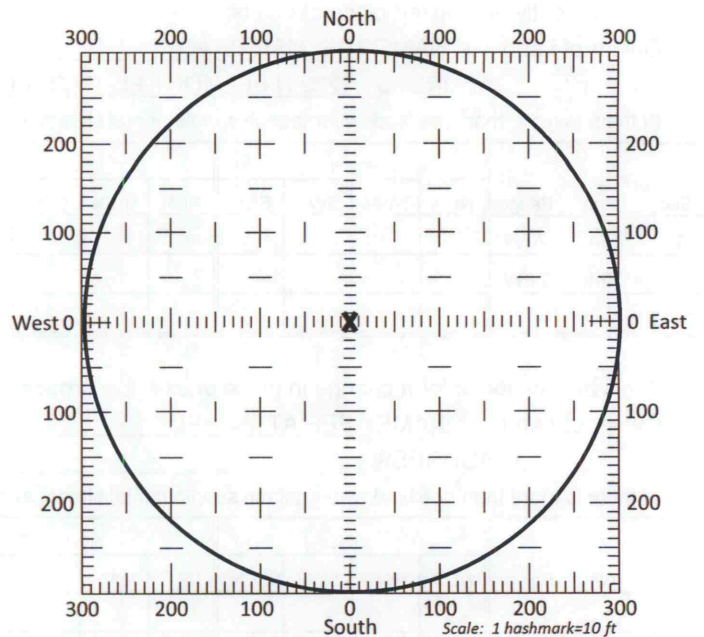

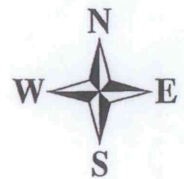
Change in Place of Use for water right 13758


