Lance Higbie and Leland Higbie, on behalf of L and M Holdings, L.L.C., have filed an application for approval to change the authorized place of use under the referenced file, authorized groundwater for irrigation use in the Rattlesnake Creek Basin.

The referenced water right does not appear abandoned as per K.S.A. 82a-718.

The referenced file number is authorized 320 acre-feet and 890 gallons per minute, all additional. There are no overlaps in the authorized point of diversion or 160-acre place of use all located in the Northeast Quarter (NE½) of Section 16, Township 26 South, Range 19 West, Edwards County, Kansas. The water right owner now proposes to authorize a total of 264 acres in the East Half (E½) of Section 16, pursuant to K.A.R. 5-5-11(b)(4) Rotation of the irrigated land within the authorized place of use. Base acres were determined to be 160 acres.

- Big Bend Kansas Groundwater Management District No. 5 will assume monitoring responsibility.
- There has been no recent pattern of water use significantly in excess of the maximum annual quantity of water authorized.
- Limitations: The maximum area authorized to be irrigated per calendar year shall be 160 acres. Use of water on more than the maximum number of acres authorized to be irrigated in any one calendar year shall result in a two-year suspension of all water use under the referenced right and subsequent restriction of the authorized place of use to a total not to exceed the base acreage at the location specifically set forth in the change approval.

The net irrigation requirement for the 50% chance of rainfall in Edwards County (1.08') with 85% efficiency is 1.27 acre-feet/acre so the water right owners have sufficient water to irrigate.

Water well owners within one-half mile of the authorized point of diversion were notified in letters dated February 24, 2017 of the proposed change in place of use to comply with Senate Bill No. 337 enacted by the Legislature of the State of Kansas, effective July 1, 2016.

The same local source of supply will not change, previously determined to be Undifferentiated Kansan/Nebraskan deposits (180).

In a letter dated March 9, 2017, Orrin Feril, Manager of Big Bend Kansas Groundwater Management District No. 5, recommended that the application be approved.

In an e-mail dated March 10, 2017, Jeff Lanterman, Water Commissioner of the Stafford Field Office, recommended approval of the referenced change application and the requirement of an anti-reverse totalizing water flowmeter and the requirement of a seal on the water flowmeter to the pipe. A check valve is required if any chemical or foreign substance is injected into the water through the diversion works.

A water flow meter is required. A check valve is required if chemigating.

Based on the above discussion, that the changes are reasonable, that impairment to existing water rights is unlikely and that no change in the local source of supply will occur, it is recommended that the referenced application be approved.

Dear Mr. Higbie:

Enclosed is the order executed by the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, approving the application for change under the above referenced file number.

Your attention is directed to the enclosures and to the terms, conditions, and limitations specified in this approval for change. A condition of this approval is that an acceptable water flow meter must be installed on the diversion works authorized under the referenced file number. Prior to the diversion of water for irrigation purposes, you must install an anti-reverse totalizing water flowmeter which meets or exceeds specifications adopted by the Chief Engineer. In addition, a seal shall be placed on the water flowmeter by the Division of Water Resources in such a manner as to render the meter non-removable from the measuring chamber without breaking the seal. Please return the required notification of completion of the diversion works and/or installation of the required meter as soon as these actions are completed.

Please be advised that K.S.A. 82a-728 of the Kansas Water Appropriation Act states in pertinent part:

... it shall be unlawful ... for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.

Approval of the application does not allow the diversion of water in excess of the authorized quantity per calendar year or rate of diversion under the above referenced file number. Your attention should be drawn to the fact that this approval has been issued solely for the purpose of allowing rotation of the irrigated land within the authorized place of use, with no more than the base acreage, 160 acres in this case, under irrigation in any one calendar year. The maximum area authorized to be irrigated per calendar year shall be 160 acres. Non-compliance with the terms of this approval will result in substantial penalties.

Since this order modifies the original document referred to above, it should be recorded with the Register of Deeds as other instruments affecting real estate.

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Lance Higbie, 2307 130<sup>th</sup> Avenue, Lewis, Kansas, 67552, and Leland Higbie, on behalf of L and M Holdings, L.L.C., 2360 P Road, Lewis, Kansas, 67552-5233, received in this office on January 6, 2017, for approval of a change in the location of the place of use under the certificate of appropriation issued pursuant to the permit to appropriate water for beneficial use, as modified and amended by the Findings and Order of the Chief Engineer dated August 3, 1979, better describing the location of the authorized point of diversion, the Findings and Order of the Chief Engineer dated July 22, 1987, reducing the authorized quantity and place of use, and by the Order of the Chief Engineer dated June 21, 1992, approving the application to change the point of diversion, finds that the change is reasonable and will not impair existing rights, and that the application should be and is hereby approved.

3. That if the Big Bend Groundwater Management District No. 5 and/or the Division of Water Resources terminate their Memorandum of Understanding (MOU) pertaining to K.A.R. 5-5-11(b),(3),(4) and (5), by which the District assumes monitoring responsibility, then the place of use authorized by this change approval, which was issued by the Division pursuant to the MOU shall revert to the property described in number 2, above, starting the calendar year following the year of termination.

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

The owner of the Water Right(s) identified in this order shall install an anti-reverse totalizing water flowmeter which meets or exceeds specifications adopted by the Chief Engineer.

A seal shall be placed on the water flowmeter by the Division of Water Resources in such a manner as to render the meter non-removable from the measuring chamber without breaking the seal. If the seal is broken without the written permission of the chief engineer, this shall create a rebuttable presumption that the point of diversion had been unlawfully operated in violation of the order of the chief engineer and that the water right holder had been acting in violation of the conditions of his or her water right. If any such violation occurs, a written order shall be issued by the chief engineer stating the nature of the violation and the civil penalty, suspension of water right or modification to the water right, or any combination of these to be imposed.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 3,417, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated December 27, 1960, as modified and amended by the aforementioned orders.

This Order shall become a final agency action, as defined by K.S.A. 77-607(b), without further notice to the parties, if a request for hearing or a petition for administrative review is not filed as set forth below.

Request for Hearing. According to K.A.R. 5-14-3(c), any party who desires a hearing must submit a request within 15 days after the date shown on the Certificate of Service attached to this Order. Filing a request for a hearing will give you the opportunity to submit additional facts for consideration, contest any findings made by the Chief Engineer or present any other information you believe should be considered in this matter. A timely-filed request for hearing will stay the deadline for requesting administrative review of this Order pending the outcome of the hearing.

Petition for Review. Any person aggrieved by this Summary Order may petition for administrative review, pursuant to K.S.A. 82a-708b(a) and K.S.A. 82a-1901(a). The petition must be filed within 30 days after the date shown on the Certificate of Service attached to this Order and must set forth the basis for the review, unless stayed by the timely filing of a request for hearing.

Any request for hearing or petition for administrative review shall be in writing and shall be submitted to the attention of: Chief Legal Counsel, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, Fax: (785) 564 - 6777.



Section 82a-728 of the Kansas Water Appropriation Act, provides (a) except for the appropriation of water for the purpose of domestic use, . . . it shall be unlawful for any person to appropriate or threaten to appropriate water from any source without first applying for and obtaining a permit to appropriate water in accordance with the provisions of the Water Appropriation Act or for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.

(b) (1) The violation of any provision of this section by any person is a class C misdemeanor...

A class C misdemeanor is punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. Each day that the violation occurs constitutes a separate offense.





(1)	Water flow meters will be required on all wells authorized by the above-reference file number. These flow meter(s) shall be properly installed and maintained of each well to the satisfaction of the Chief Engineer. The metered quantity of water diverted during the past year by each well shall be reported on the annual water us report required by law to be provided to the Division of Water Resource (Division).
(2)	Big Bend Groundwater Management District No. 5 (GMD No. 5) will make a least one visit per calendar year to this farm. The purpose of this visit is to monito the compliance with conditions under which this change will be approved, granted. Reports of verification of compliance and status reports will be completed by GMD No. 5 and furnished to the Division.
(3)	The amount of water required to irrigate the acreage proposed under this chang application has been reviewed. The five year allocation, if required, has bee reviewed and is understood to be acre feet. The five year allocation the quantity of water that will be authorized for diversion under this water right for each five year period.
(4)	The approval of this application will be conditioned so that any use of water is excess of the five-year allocation will result in a two-year suspension of all water use under that water right and a subsequent restriction of the authorized place of use to a place of use equivalent to the base acres at a location specifically set fort on the change application approval.
(5)	For an application that proposes an increase in authorized acres solely for the purpose of rotation of the irrigated land within the authorized place of use, the base acres are 160 acres.
