

The Equus Beds Groundwater Management District No. 2 reviewed the referenced change in place of use applications on August 7, 2017, using the District's Revised Management Program (effective May 1, 1995) and Rules and Regulations K.A.R. 5-22-1 through 5-22-17.

The change applications propose to increase the place of use from 238 acres to 246.5 acres and an identical place of use overlap will exist between Water Right Nos. 5642 & 33142, resulting in a water to land ratio of 1.087 acre-feet per acre.

If more time is needed to install the meters or modify an existing meter installation, you may request an extension of time. The request must be made to the District before the end of the 30-day period.

A copy of the Division of Water Resources' meter installation notification form (Notice and Proof of Completion of Works) may be substituted for the District form. Upon receiving the completed forms, the District will inspect the installations.
