Martin Ternes, tenant of File No. 48,988 has filed an application for approval to change the place of use and a new application to appropriate water for beneficial use, File No. 50,060 for irrigation use. The applications were received on February 21, 2019.

Change Application File No. 48,988

The referenced file number do not appear to be abandoned as per K.S.A. 82a-718. The landowner, Leo Hattrup, has signed the application.

File No. 48,988 is currently authorized 99 acre-feet of groundwater to be diverted at a maximum rate of 800 gallons per minute from a battery of wells with a geographic center located in the Northwest Quarter of the Northwest Quarter (NW¼ NE¼) of Section 14, more particularly described as being near a point 4,637 feet North and 2,127 feet West of the Southeast corner of said section, in Township 30 South, Range 1 West, Sumner County, Kansas. New Application, File No. 50,060 will create a complete overlap in point of diversion and place of use.

The place of use is currently 76 acres in the Northeast Quarter (NE¼) of Section 14. This application for change in place of use proposes to add 75 acres located in the Northeast Quarter (NE¼) of Section 14. This will create an overlap in place of use with New Application, File No. 50,060. The additional acres will be covered by the quantity appropriated under File No. 50,060 thus there is no increase in consumptive use with the proposed change in place of use.

The applicant identified four (4) nearby wells not owned by the applicant located within one-half mile of this existing well. Nearby well owner letters were sent out on February 27, 2019, referencing the proposed change application and new application. No response of any kind has been received.

Based on the above discussion, the change is reasonable, the application complies with consumptive use criteria, approval of the application will not impair senior water rights nor prejudicially or unreasonably affect the public interest. It is recommended that the referenced application be approved to create a complete overlap with New Application, File No. 50,060.

New Application, File No. 50,060.

The filed new application is proposing to appropriate 81.38 acre-feet of groundwater at a diversion rate of 800 gallons per minute for irrigation use in the Ninnescah River Basin. The applicant proposes to withdraw from an existing battery of wells with a geographic center located in the Northwest Quarter of the Northwest Quarter (NW¼ NW¼ NE½) of Section 14, more particularly described as being near a point 4,637 feet North and 2,127 feet West of the Southeast corner of said section, in Township 30 South, Range 1 West, Sumner County, Kansas. This is a complete overlap with Appropriation of Water, File No. 48,988.

The proposed place of use is 151 acres located in the Northeast (NE¼) of Section 14. This will create an overlap in place of use with Appropriation of Water, File No. 48,988. The proposed quantity of 81.38 acre-feet per calendar year combined with the appropriated quantity of 99 acre-feet under File No. 48,988 provides 1.19 acre-feet per acre, making it within the reasonable quantity for Sumner County (1.3).

The test hole log is the same log used for the senior file. The static water level was 15 feet below ground surface with a saturated thickness of 26 feet. Other test hole logs provided by the applicant during the senior files investigation showed similar or less saturated thickness within the overall area. A saturated thickness of 25 feet has been the cutoff requirement used to determine if additional information, i.e. an aquifer pumping test, was required. Additional was not required for either application.

DWR completed an evaluation of a USGS model and has determined that the precipitation recharge value of 5.4 inches per year that is used in the USGS model is reasonable and appropriate. In order to reserve water in the alluvial aquifers that can contribute to base flow to area streams and for domestic use, it was determined that 75 percent of the 5.4 inches of precipitation recharge shall be available for appropriation. This is consistent with safe yield appropriation in many other basins across the state and is the current percent available for applications in the Arkansas River basin in the area. Therefore, for pending applications within the model area, safe yield will be valuated using the standard methodology in K.A.R. 5-3-11, which is based on the extent of the unconfined aquifer (area of consideration), a potential annual recharge value of 5.4 inches, and a percent of recharge available for appropriation of 75 percent.

Per the requirements in K.A.R. 5-3-11, safe yield is determined by the extent of the unconfined aquifer within a two-mile circle radius of the point of diversion, which establishes the area of consideration. Evaluation of the area of consideration included the extent of the unconfined aquifer, which provided an area of consideration of 6,013 acres. With a potential annual recharge of 5.4 inches, and 75% of recharge available for appropriation, safe yield was determined to be 2,029.39 acre-feet. Existing water rights have appropriated 579 acre-feet, providing a difference of 1,450.39 acre-feet available for appropriation, and the application requesting 81.38 acre-feet complies with safe yield.

According to the WRIS database, the nearest non-domestic point of diversion (File No. 34,238) is located over 2,191 feet away. The applicant identified three (3) nearby wells not owned by the applicant located within one-half mile of this existing well. There does not appear to be any domestic well within 660 feet. Nearby well owner letters were sent out on February 27, 2019, referencing the proposed change application and new application. No response of any kind has been received. Per the requirements of K.A.R. 5-4-4 for all other aquifers, the minimum well spacing should be one-quarter mile to all other non-domestic wells, therefore the proposed point of diversion meets minimum well spacing criteria.

In a May 15, 2019 e-mail, Jeff Lanterman, Water Commissioner, Stafford Field Office, recommended approval of the application.

In accordance with K.S.A. 82a-706c, the Chief Engineer retains full authority to require any water user to install meters, gages, or other measuring devices, which devices he or she or his or her agents may read at any time. Water flowmeter requirements are further described in K.A.R. 5-1-4 through K.A.R. 5-1-12. If any chemical or foreign substance is injected into the water pumped under this permit, a check valve will also need to be installed.

Based on the above discussion, the area is open to new appropriations, the application complies with safe yield and well spacing criteria, approval of the application will not impair senior water rights nor prejudicially or unreasonably affect the public interest. It is recommended that the referenced application be approved and create a complete overlap with Appropriation of Water, File No. 48,988.

That the authorized source from which the appropriation shall be made is groundwater, to be withdrawn by means of a battery of four (4) wells, the geo-center of which is located in the Northwest Quarter of the Northwest Quarter (NW½ NE½) of Section 14, more particularly described as being near a point 4,637 feet North and 2,127 feet West of the Southeast corner of said section, in Township 30 South, Range 1 West, Sumner County, Kansas located substantially as shown on the topographic map accompanying the application.
- 4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of 800 gallons per minute (1.78 c.f.s.) and to a quantity not to exceed 81.38 acre-feet of water for any calendar year.
- 5. That installation of works for diversion of water shall be completed on or before <u>December 31</u>, <u>2020</u> or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

6. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before <u>December 31, 2024</u> or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

- 7. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.
- 8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.
- 9. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.
- 10. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.
- 11. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.
- 12. That all wells with a diversion rate of 100 gallons per minute or more drilled under the authority of this permit shall have a tube or other device installed in a manner acceptable to, and in accordance with specifications adopted by, the Chief Engineer. This tube or device shall be suitable for making water level measurements and shall be maintained in a condition satisfactory to the Chief Engineer.
- 13. That an acceptable water flow meter shall be installed and maintained on the diversion works authorized by this permit in accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. This water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).
- 14. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1 following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.
- 15. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.
- 16. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.
- 17. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.

- 18. That this permit is further limited such that all four (4) wells shall be located within a three hundred (300) foot radius circle, in the same local source of supply and be limited to a total maximum diversion rate not in excess of 800 gallons per minute (1.78 c.f.s.).
- 19. That the rate of diversion of water approved under this permit is further limited to the rate which combined with Appropriation of Water, File No. 48,988, will provide a total **not to exceed 800 gallons per minute** (1.78 c.f.s.) from the authorized point of diversion.



Jeff, we approved a new application a couple years ago for a battery of wells on a partial pivot. They want to expand the pivot and have filed a p/u change and a new application to cover this expansion. The new app requests an additional The quantity is reasonable, the p/d is a complete overlap on the existing battery, the p/u will be a complete overlap if the new app and change are approved. I should note the new app has an "odd" quantity requested at 81.38 AF so the total that can be applied here is 81.38 AF + 99 AF = 180.38 AF on 151 acres...1.19 AF/acre but the acres will get reduced come cert time b/c they will likely only do the pivot so there should be plenty of water to perfect 1.3 AF/acre on the actual place of use.

The original file only had about 26' of saturated thickness, we didn't require any type of study as it didn't meet the LST threshold. The same nearby owners were notified of the new app and there were no responses for this new application (there were no responses of concern for the original application either). The nearest permitted well is over 1.5 miles away and the nearest domestic wells meet spacing as shown on the map.

http://hercules.kgs.ku.edu/geohydro/wizard/wizardwelldetail.cfm?usgs_id=372522097170701 (this is one of the new tri-annual wells we started measuring back in 2015 and is located about 1.5 miles south of the proposed wells across the river, not so helpful right now but gonna be nice in the future I'm sure!)

I think this increase in quantity and the p/u change can be recommended for approval. Please pass on to Austin if you agree that this change and new can be approved.

Austin----please make sure the change application has an appropriate map showing the exact place of use overlap with the new application. I currently don't see a map with the p/u change and a map is required and necessary. Also, your attached revised new app seems to correctly show the acreage being a complete overlap so that is good (WRIS is wrong now but that is no surprise b/c there was a revision from original).

Note: If an application requests both direct use and storage, the fee charged shall be as determined under No. 1 or No. 2 above, whichever is greater, but not both fees.

3. The fee for an application for a permit to appropriate water for water power or dewatering purposes shall be \$100.00 plus \$200.00 for each 100 cubic feet per second, or part thereof, of the diversion rate requested.

The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works for diversion has been completed, except that for applications filed on or after July 1, 2009, for works constructed for sediment control use and for evaporation from a groundwater pit for industrial use shall be accompanied by a field inspection fee of \$200.00.

As a matter of record, the Division of Water Resources has on hand a large number of applications awaiting processing. Therefore to be fair to all concerned, and so that we can process those applications on hand in the order they were received, we intend to concentrate on the backlog of applications until the issue is resolved. Once review of your application has begun, we will contact you, if additional information is required.

In accordance with the provisions of the Kansas Water Appropriation Act, a portion of which is included below, the use of water as proposed prior to approval of the application is unlawful. Once approved, compliance with the terms, conditions and limitations of the permit is necessary. Conservation of the water resources of Kansas is required.

Section 82a-728 of the Kansas Water Appropriation Act, provides (a) except for the appropriation of water for the purpose of domestic use, ... it shall be unlawful for any person to appropriate or threaten to appropriate water from any source without first applying for and obtaining a permit to appropriate water in accordance with the provisions of the Water Appropriation Act or for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.

(b) (1) The violation of any provision of this section by any person is a class C misdemeanor . . .

A class C misdemeanor is punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. Each day that the violation occurs constitutes a separate offense.


