ADDITIONAL CONDITIONS TO SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS, Water Right, File Nos. 23,638

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the following condition is included as a condition of the approval of this application for change in point of diversion.

That the point of diversion (well) authorized by the application for change in point of diversion shall be screened no deeper than 69' below land surface, which is considered to be the bottom of the alluvium aquifer at this location. Any casing placed below 69' below land surface shall not be screened and the annular space outside of the casing below 69' below land surface shall be grouted according to rules and regulations promulgated by the Kansas Department of Health and Environment Article 30 so as to not allow production of water from underlying Cretaceous Aquifers.
