

This is a memorandum regarding surrounding well owner notification for applications to change the place of use for irrigation water rights and the decisions made during the Water Commissioner meeting which took place on 11/16/2016 with directive from Lane Letourneau, Program Manager.

This is applicable to field office changes to increase the place of use by 10 acres or 10% (whichever is less) or a change in place of use to create a complete overlap in which no new acres are being irrigated.

During that meeting it was determined that no surrounding well owner notification will be sent under this type of place of use change application. All well rates and quantities will remain unchanged and the referenced change should not cause impairment or impact surrounding well owners.

The application to change the place of use filed on <u>3/22/2021</u> for the above referenced files meets this criterion, therefore, well owners surrounding the authorized point of diversion will not be notified.

Bronson Smith, on behalf of ILS Land LLC, the owner of the referenced water right authorized for irrigation use, has applied for approval to change the authorized place of use. An authorized representative of the owner signed the application. A copy of a deed showing ILS Land LLC as the landowner was received by email on March 10, 2021.

The referenced file appears to be in compliance with 82a-732 (Annual water use report required). A review of the application found that it complies with K.A.R. 5-5-1, *Filing an application for change*. The referenced file does not appear abandoned as per K.S.A. 82a-718.

The referenced file authorizes 40 acres in the East Half of the Northwest Quarter (E½ NW¼) of Section 16, Township 20 South, Range 14 West, Barton County. There are no overlapping water rights on the place of use or the point of diversion.

File No. 35307 authorizes one (1) well in the Northwest Quarter of the Northeast Quarter of the Northwest Quarter (NW½ NE½ NW½) of Section 16, more specifically described as 4,375 feet North and 3,943 feet West of the Southeast corner of said section, in Township 20 South, Range 14 West, Barton County. A field visit conducted on October 13, 2011 by personnel from Big Bend Groundwater Management District No. 5 (GMD5) found the water right to not be in compliance due to the meter installation. No modifications are being made to the point of diversion description.

File No. 35307 authorizes 60 acre-feet (AF) at 755 gallons per minute. The file is certified.

The change application, received on March 22, 2021, proposes to change the authorized place of use to allow for the installation of a center pivot system. The place of use is currently set up for flood irrigation. A review of the files determined that there are 40 'base acres' as defined by K.A.R. 5-5-11(a)(1). Applications for change in place of use for irrigation purposes. The proposed 40.5 acres complies with part (b) of K.A.R. 5-5-11 and the 10 percent increase above the Base Acres is allowed by the regulation.

The proposed change will result in a quantity of 40 AF irrigating 40.5 acres, resulting in an irrigation ratio of 1.48 AF per acre. It would appear this irrigation ratio is reasonable as the ratio is less than the pre-2000 maximum quantity per acre of 1.5 AF for Barton County found in K.A.R. 5-3-19, *Maximum reasonable annual quantity for water for irrigation use*, thus complying with K.A.R. 5-3-23, *Maximum reasonable annual quantity approvable for irrigation use for an application for change in place of use and a request to reduce a water right.* The generally accepted minimum quantity per acre for Barton County is 1.18 AF per acre, so the proposed quantity also meets this threshold.

File Nos. 35307 Change in P/D & P/U Memo April 7, 2021

The referenced application to change the place of use does not propose to add more than 10 acres or 10% of the base acres to the authorized place of use. Therefore, water well owners within one-half mile of the authorized point of diversion were not notified of the proposed change in place of use (EKF Memo dated 3/2/2021).

The referenced water appropriation is not in a special use area.

Water Right, File No. 35307 is in GMD5, so a recommendation request was sent to the District on March 25, 2021. A response was received from GMD5 Manager, Orrin Feril on April 6, 2021. In his response, Mr. Feril recommended approval for the change application.

No structures permit appears to be needed.

A water flow meter is required for the authorized point of diversion. A check valve is required if any chemical or foreign substance is injected into the water through the diversion works.

Based on the above discussion, that the change is reasonable, that impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it has been recommended that application be approved.
