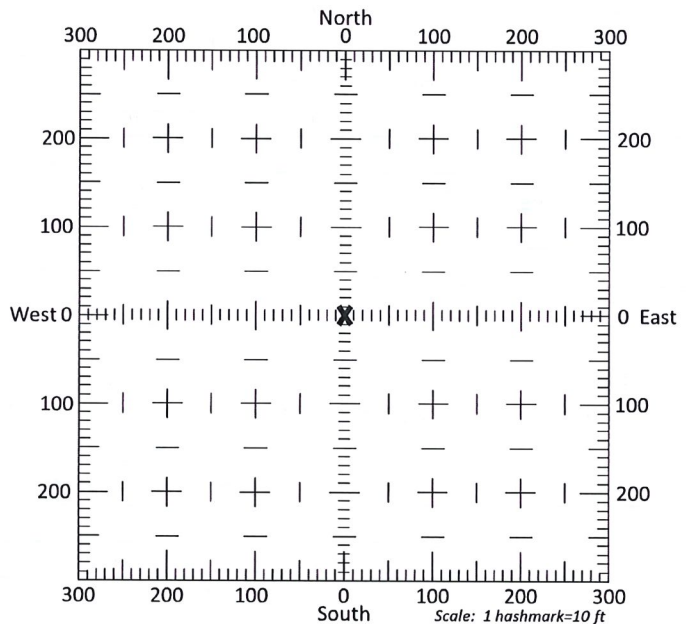

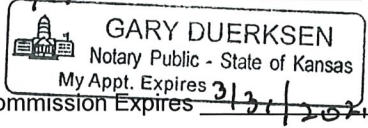

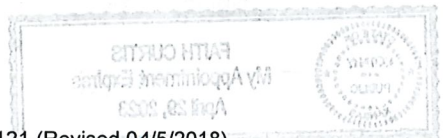

SUMMARY ORDER APPROVING APPLICATION FOR CHANGE AND IMPOSING CONDITIONS

This Summary Order is issued under authority of K.S.A. 82a-708b, as amended, and K.A.R. 5-5-1, *et seq.* and other applicable provisions of the *Kansas Water Appropriation Law, K.S.A. 82a-701 et seq.*, and rules and regulations promulgated thereunder, With the exception of those conditions expressly contained herein, this Summary Order does not change the terms, conditions and limitations of File No. 48341.

1. A change application was received on August 26, 2020 requesting that the place of use and / or point of diversion authorized under the above-referenced file number be changed as described in the application.

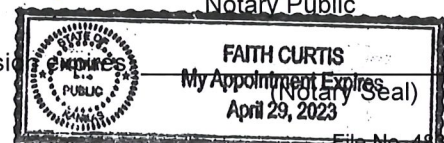

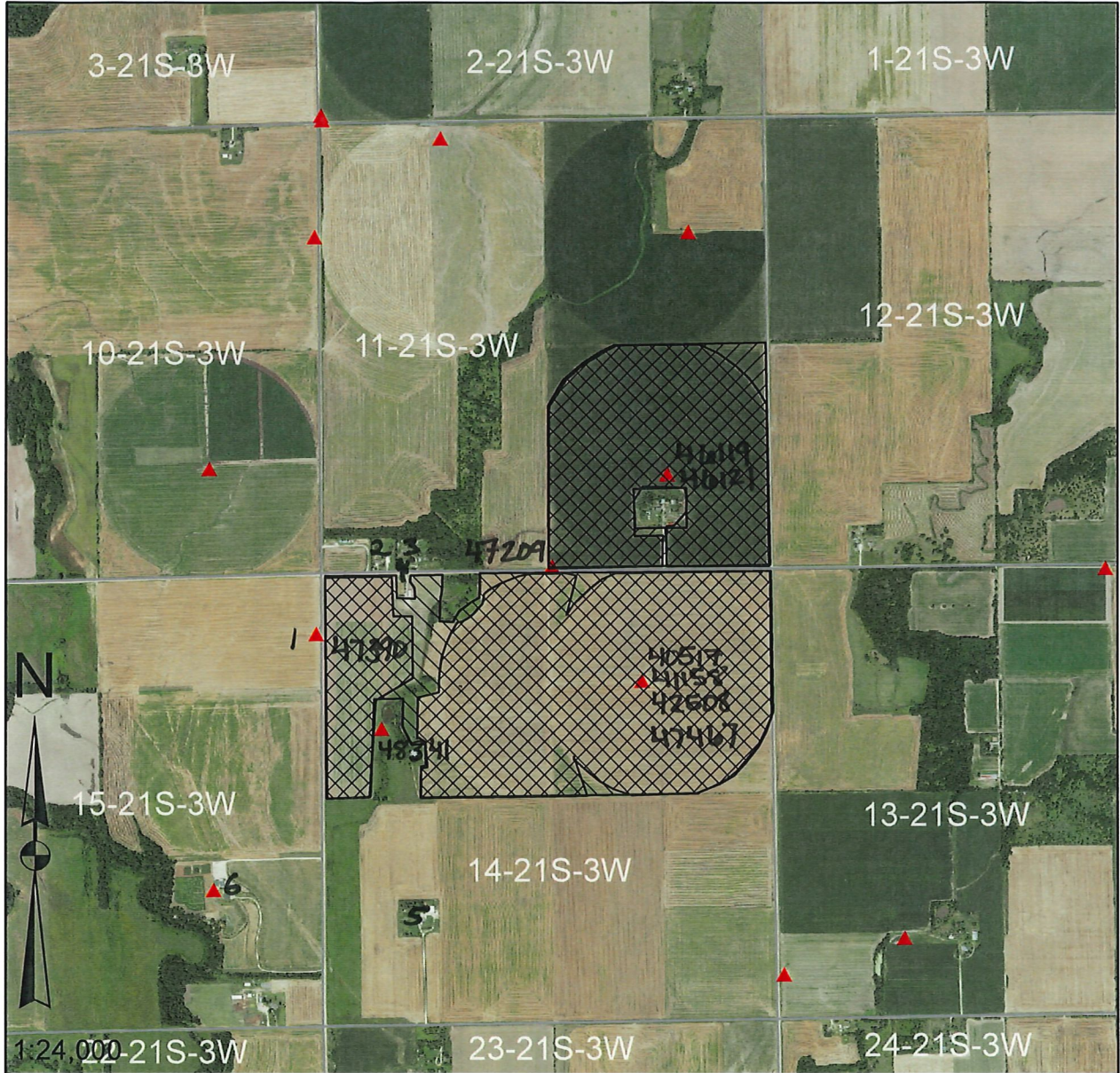

Larry L Stucky, on behalf of CNS Land LLC and Harold D & Pearl L Zerger as owners of the referenced files authorized for irrigation use, has submitted eight (8) applications for approval to change the authorized place of use. All the owners of record signed all eight (8) applications.

The referenced files appear to be in compliance with 82a-732 (Annual water use report required). A review of the applications found that they comply with K.A.R. 5-5-1, *Filing an application for change*. The referenced files do not appear abandoned as per K.S.A. 82a-718. All the referenced applications are in McPherson County, Kansas.

All of the referenced files currently have an overlapped place of use on 148.4 acres authorized in the Southeast Quarter (SE $\frac{1}{4}$) of Section 11 and 270.5 acres authorized in the North Half (N $\frac{1}{2}$) of Section 14, all in Township 21 South, Range 3 West. This is a total of 418.9 acres. All legal descriptions from here on are located in Township 21 South, Range 3 West, McPherson County.

File Nos. 40517, 41185, 42508 & 47467

File No. 40517, 41185, 42508 and 47467 currently authorize the same well near the center of the Northeast Quarter (NE $\frac{1}{4}$) of Section 14, more specially described as 3,997 feet North and 1,506 feet West of the Southeast corner of said section. A compliance inspection on May 1, 2018, found the water rights to be out of compliance due to the irrigation of unauthorized acres. No modifications are being made to the point of diversion description.

- **File No. 40517** authorizes 64 acre-feet (AF) at 640 gallons per minute (gpm) and has 65 base acres. This file is certified.
- **File No. 41185** authorizes 46 AF at 940 gpm, limited to 940 gpm when combined with File No. 40517. File No. 41185 has 32.5 base acres, all additional. This file is certified.
- **File No. 42508** authorizes 167 AF at 1,200 gpm, limited to 1,200 gpm when combined with File No. 40517 and 41185. File No. 42508 has 112 base acres, all additional. This file is certified.
- **File No. 47467** authorizes 64 AF at 736 gpm, limited to 64 AF per year and 736 gpm when combined with File No. 40517. File No. 47467 is also limited to 1,296 gpm when combined with File Nos. 40517, 41185 and 42508. File No. 47467 is not certified, so the base acres are 418.9 acres (90.4 additional).

File No. 46119 & 46121

File No. 46119 and 46121 currently authorize the same well in the Northwest Quarter of the Southeast Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 11, more specially described as 1,111 feet North and 1,167 feet West of the Southeast corner of said section. A

compliance inspection on May 1, 2018, found the water rights to be out of compliance due to the irrigation of unauthorized acres. No modifications are being made to the point of diversion description.

- File No. 46119 authorizes 99.5 AF at 470 gpm and has 109 base acres. This file is certified.
- File No. 46121 authorizes 29.5 AF at 470 gpm, limited to 470 gpm when combined with File No. 46119. File No. 46121 has 109 base acres (zero additional). This file is certified.

File No. 47209

File No. 47209 authorizes a well in the Southwest Quarter of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 11, more specially described as 48 feet North and 2,554 feet West of the Southeast corner of said section. A compliance inspection on May 1, 2018, found the water right to be out of compliance due to the irrigation of unauthorized acres. No modifications are being made to the point of diversion description.

File No. 47209 authorizes 158 AF at 1,000 gpm, limited to 406 AF when combined with File No. 40517, 41185, 42508, 46119 and 46121 and has a base of 328.5 acres (10 additional). This file is certified.

File No. 48341

File No. 48341 authorizes a well in the Northeast Quarter of the Southwest Quarter of the Northwest Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 14, more specially described as 3,508 feet North and 4,561 feet West of the Southeast corner of said section. A compliance inspection on May 1, 2018, found the water right to be out of compliance due to the irrigation of unauthorized acres. The authorized point of diversion will be better described based on GPS coordinates.

File No. 48341 authorizes 94.9 AF at 1,000 gpm, limited to 512.55 AF and has a base of 418.9 acres (zero additional). This file is not certified.

The referenced change applications, received on August 26, 2020, propose to maintain the existing overlap under the associated water rights while modifying the acreage to cover the center pivot system that is currently irrigating unauthorized acres in the Northwest Quarter of Section 14, along with a few other minor adjustments. The combined acres for the eight (8) water appropriations will go from 418.9 acres to 428.9 acres located in Sections 11 and 14, Township 21 South, Range 3 West, McPherson County.

When combined, these files authorize a total 418.9 "Base Acres," as defined by K.A.R. 5-5-11. The proposed 428.9 acres complies with part (b) of K.A.R. 5-5-11 and the 10 acre increase above the *Base Acres* is allowed by the regulation.

The proposed changes will result in a maximum quantity of 512.55 AF irrigating 428.9 acres, resulting in an irrigation ratio of 1.20 AF per acre. It would appear this irrigation ratio is reasonable as the ratio is less than the 1.3 AF per acre maximum for McPherson County found in K.A.R. 5-3-24, *Reasonable quantity for irrigation use*, thus complying with K.A.R. 5-3-23, *Maximum reasonable annual quantity approvable for irrigation use for an application for change in place of use and a request to reduce a water right*. The generally accepted minimum quantity per acre for McPherson County is 1.06 AF per acre, so the proposed quantity meets this threshold as well.

Since the referenced applications to change the place of use do not propose to add more than 10 acres or 10% of the base acres to the authorized place of use, water well owners within one-half mile of the authorized point of diversion were not notified of the proposed change in place of use (EKF Memo dated 09/29/2020).

The referenced water appropriations are not in a special use area.

The referenced water rights are in the Equus Beds Groundwater Management District No. 2 (GMD2), so a recommendation request was sent to the District on September 3, 2020. A response was received from GMD2 Manager, Tim Boese on September 29, 2020. In his response, Mr. Boese recommended approval for the change applications filed under each of the referenced file numbers.

There appears to have been a channel change associated with the west pivot in the Northwest Quarter of Section 14. The proper structures permit was approved under CMP-0134.

A water flow meter is required for each point of diversion. A check valve is required if any chemical or foreign substance is injected into the water through the diversion works.

Based on the above discussion, that the change is reasonable, that impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it has been recommended that applications are approved.

This is a memorandum regarding surrounding well owner notification for applications to change the place of use for irrigation water rights and the decisions made during the Water Commissioner meeting which took place on 11/16/2016 with directive from Lane Letourneau, Program Manager.

This is applicable to field office changes to increase the place of use by 10 acres or 10% (whichever is less) or a change in place of use to create a complete overlap in which no new acres are being irrigated.

During that meeting it was determined that no surrounding well owner notification will be sent under this type of place of use change application. All well rates and quantities will remain unchanged and the referenced change should not cause impairment or impact surrounding well owners.

The application to change the place of use filed on 08/26/2020 for the above referenced files meets this criterion, therefore, well owners surrounding the authorized point of diversion will not be notified.
