DD-CO LLC filed the above referenced application to appropriate groundwater for irrigational use and requested 60 days to locate the point of diversion on March 11, 2022. The application was returned to the applicant on March 21, 2021, providing 60 days to locate the point of diversion, provide additional information, and return the application by a May 21, 2022 deadline. Multiple extensions were given with the latest being for September 21, 2022.

The application has not been returned with locations identified by the September 21, 2022, deadline. Therefore, it is recommended that the application be dismissed.

FINDINGS AND ORDER IN THE MATTER OF THE DISMISSAL OF APPLICATION FILE NO. 50,739

After due consideration, the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture (hereinafter referred to as the "Chief Engineer"), makes the following findings and order:

FINDINGS

1. That on March 11, 2022, the Chief Engineer received an application from DD-CO LLC for a permit to appropriate groundwater for beneficial use, assigned File No. 50,739, proposing the appropriation of 141.6 acre-feet of water, at a maximum requested diversion rate of 800 gallons per minute, for irrigation use.
2. That the applicant requested 60 days to locate the specific point of diversion within the Southwest Quarter (SW $\frac{1}{4}$) of Section 36, Township 33 South, Range 3 East, Cowley County, Kansas.
3. That on March 21, 2022, the incomplete application was returned to the applicant, with a cover letter stating that additional information must be submitted in order to complete the application. The applicant was provided a deadline of May 21, 2022, the time in which to provide the requested information and return the application. The applicant was informed that the application would be dismissed if it was not returned by the deadline, or within any authorized extension of time.
4. That the applicant requested and was granted multiple extensions of time, with the last extension allowing until September 21, 2022, for return of the application with the required information.
5. That electronic correspondence received in the office of the Chief Engineer on September 19, 2022, and October 17, 2022, indicated that all plans to proceed with the pending application had been abandoned and that the application should be dismissed.
6. That since the application was not returned by the September 21, 2022, deadline, it should be dismissed and its priority forfeited as provided by K.S.A. 82a-710.

ORDER

NOW, THEREFORE, It is the decision and order of the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, that effective the date of this order, in accordance with the law, Application, File No. 50,739, is herewith dismissed and the priority assigned to it is considered to be forfeited.


