## **FINDINGS AND ORDER IN THE MATTER OF THE DISMISSAL OF APPLICATION FILE NO. 50,758**

After due consideration, the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture (hereinafter referred to as the "Chief Engineer"), makes the following findings and order:

### **FINDINGS**

1. That on April 4, 2022, the Chief Engineer received an application from Michael Andra for a permit to appropriate groundwater for beneficial use, assigned File No. 50,758, proposing the appropriation of 99.5 acre-feet of water, at a maximum requested diversion rate of 800 gallons per minute, for irrigation use. The applicant requested 60 days to locate the specific point of diversion near the center of Section 18, Township 28 South, Range 1 East, Sedgwick County, Kansas.
2. That on April 14, 2022, the original application was returned to the applicant, with a cover letter requesting that additional information be submitted in order to complete the application. The applicant was provided a deadline of June 14, 2022, the time in which to provide the requested information and return the application. The applicant was informed that the application would be dismissed if it was not returned by the deadline, or within any authorized extension of time.
3. That the applicant was provided a reminder letter on May 10, 2022, to return the requested information and application by the June 14, 2022.
4. That the original application was not returned by the June 14, 2022 deadline.
5. That the application should be dismissed and its priority forfeited as provided by K.S.A. 82a-710

**ORDER**

NOW, THEREFORE, It is the decision and order of the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, that effective the date of this order, in accordance with the law, Application, File No. 50,758, is herewith dismissed and the priority assigned to it is considered to be forfeited.


