FINDINGS AND ORDER

IN THE MATTER OF THE DISMISSAL OF APPLICATION FILE NO. 50,437

After due consideration, the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture (hereinafter referred to as the "Chief Engineer"), makes the following findings and order:

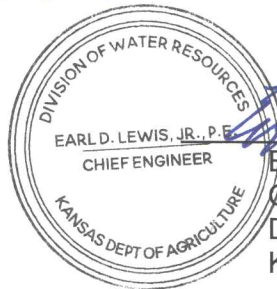
FINDINGS

1. That on September 3, 2020, the Chief Engineer received an application from Joseph Tempesta, on behalf of JDT Ranch LLC, for a permit to appropriate water for beneficial use, assigned File No. 50,437, proposing the appropriation of 320 acre-feet of surface water for recreational use, to be diverted by means of a proposed pumpsite located in the Southeast Quarter of the Northeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 22, more particularly described as being near a point 1,969 feet North and 597 feet West of the Southeast corner of said section, in Township 34 South, Range 5 West, Harper County, Kansas.
2. That on April 29, 2022, September 8, 2022, March 6, 2023, and June 5, 2023, letters were mailed to the applicant, stating that the application was incomplete and that a Floodplain Development Application would need to be submitted to complete the application.
3. That on August 25, 2023 a letter was sent to the applicant, stating that additional information must be submitted in order to complete the application, including a complete water structures application, giving the applicant until October 25, 2023, in which to provide the requested information, and that the application would be dismissed if it was not returned by the deadline, or within any authorized extension of time.
4. That the required information has not been submitted to the office of the Chief Engineer and no request of an extension of time was received on or before the October 25, 2023, deadline.
5. That the application should be dismissed, and its priority forfeited as provided by K.S.A. 82a-710.

ORDER

NOW, THEREFORE, It is the decision and order of the Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, that effective the date of this order, in accordance with the law, Application, File No. 50,437, is hereby dismissed and the priority assigned to it is considered to be forfeited.

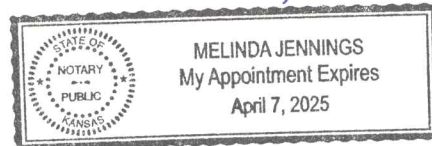
