James L. Roberts IV has filed the above-referenced application requesting to appropriate 15 acre-feet of groundwater for recreational use at a maximum diversion rate of 100 gallons per minute, from one (1) well located in the Northeast Quarter of Section 34, Township 25 South, Range 9 West, Reno County, Kansas. The application has been signed by Mr. Roberts, stating he has access to the point of diversion. This application was filed to obtain water for a duck marsh. The place of use will be said marsh (5-acre surface area), located in the Southeast Quarter Half of the Northeast Quarter of Section 34, Township 25 South, Range 9 West, Reno County, Kansas. Mr. Roberts owns the entire place of use.

The requested quantity of water under this application (15 acre-feet) was determined by inundating the 5-acre marsh area with 2.0 feet of water; and the applicant planning to fill the marsh two times per year; an initial fill and as second filling to offset indirect loss of water. Typically, these types of marshes are filled in October prior to waterfowl migration.

5 acres x 1.5 feet = 7.5 AF per fill 2 fills = 7.5 AF + 7.5 AF = **15 AF per year**

Two well owners were identified within one-half mile of the proposed point of diversion. Nearby notification letters outlining the application were mailed on October 27, 2023. No responses of any kind have been received to date.

There are no non-domestic wells within a two-mile radius of the point of diversion. The closest domestic well is roughly 1,350 feet away. Therefore, according to K.A.R. 5-4-4, spacing criteria is met.

A Compatible Use Agreement (CUA) for water level management to the National Resources Conservation Service (NRCS) for pumping water onto a Wetlands Reserve Program easement area will not be required. In an email conversation with Brent Turney, NRCS Easement Specialist, on October 27, 2023, he confirmed that no easement was present at the marsh location.

Janelle Phillips, Stream Obstruction Team Lead, informed the applicant that a floodplain fill permit would be required for their project. Mr. Roberts submitted a fill application on December 22, 2023. In discussions with Kristen Baum, New and Change Application Unit Supervisor, the Water Appropriation Unit feels comfortable approving File No. 50,853, knowing the Water Structures Unit has the referenced floodplain fill application in hand.

In accordance with K.S.A. 82a-706c, the Chief Engineer retains full authority to require any water user to install meters, gages, or other measuring devices, which devices he or she or his or her agents may read at any time. Water flowmeter requirements are further described in K.A.R. 5-1-4 through K.A.R 5-1-12. If any chemical or foreign substance is injected into the water pumped under this permit, a check valve will also need to be installed.

In a letter dated July 19, 2023, Orrin Feril, Manager of Big Bend Groundwater Management District No. 5, recommended approval of the referenced application. The application is exempt from the closure of the district per K.A.R. 5-25-4(b) and meets the requirements of K.A.R. 5-25-15(a).

In an email discussion on November 21, 2023, Jeff Lanterman, Water Commissioner of the Stafford Field Office, recommended approval of the referenced application.

Based on the above discussion, the area is open to new applications, meets spacing requirements, and there is no indication that the proposed beneficial use of water will impair existing water rights. Therefore, it is recommended that the referenced application be approved.

This is to certify that I have examined Application, File No. 50,853 of the applicant

for a permit to appropriate water for beneficial use, together with the maps, plans and other submitted data, and that the application is hereby approved and the applicant is hereby authorized, subject to vested rights and prior appropriations, to proceed with the construction of the proposed diversion works (except those dams and stream obstructions regulated by K.S.A. 82a-301 through 305a, as amended), and to proceed with all steps necessary for the application of the water to the approved and proposed beneficial use and otherwise perfect the proposed appropriation subject to the following terms, conditions and limitations:

- 1. That the priority date assigned to such application is **September 6, 2022.**
- 2. That the water sought to be appropriated shall be used for recreational use in a marsh located in the Southeast Quarter of the Northeast Quarter (SE¼ NE½) of Section 34, in Township 25 South, Range 9 West, Reno County, Kansas.
- 3. That the authorized source from which the appropriation shall be made is groundwater, to be withdrawn by means of one (1) well located in the Northwest Quarter of the Northwest Quarter of the Northeast Quarter (NW½ NW½ NE½) of Section 34, more particularly described as being near a point 4,846 feet North and 1,252 feet West of the Southeast corner of said section, in Township 25 South, Range 9 West, Reno County, Kansas, located substantially as shown on the topographic map accompanying the application.
- 4. That the appropriation sought shall be limited to a maximum diversion rate not in excess of 99 gallons per minute (0.22 c.f.s.) and to a quantity not to exceed 15 acre-feet of water for any calendar year.
- 5. That installation of works for diversion of water shall be completed on or before <u>December 31</u>, <u>2025</u>, or within any authorized extension thereof. The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works has been completed. Failure to timely submit the notice and the fee will result in revocation of the permit. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.

- 6. That the proposed appropriation shall be perfected by the actual application of water to the proposed beneficial use on or before <u>December 31, 2029</u>, or any authorized extension thereof. Any request for an extension of time shall be submitted prior to the expiration of the deadline and shall be accompanied by the required statutory fee of \$100.00.
- 7. That the applicant shall not be deemed to have acquired a water appropriation for a quantity in excess of the amount approved herein nor in excess of the amount found by the Chief Engineer to have been actually used for the approved purpose during one calendar year subsequent to approval of the application and within the time specified for perfection or any authorized extension thereof.
- 8. That the use of water herein authorized shall not be made so as to impair any use under existing water rights nor prejudicially and unreasonably affect the public interest.
- 9. That the right of the appropriator shall relate to a specific quantity of water and such right must allow for a reasonable raising or lowering of the static water level and for the reasonable increase or decrease of the streamflow at the appropriator's point of diversion.
- 10. That this permit does not constitute authority under K.S.A. 82a-301 through 305a to construct any dam or other obstruction; nor does it grant any right-of-way, or authorize entry upon or injury to, public or private property.
- 11. That all diversion works constructed under the authority of this permit into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic quick-closing, check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.
- 12. That an acceptable water flow meter shall be installed and maintained on the diversion works authorized by this permit in accordance with Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water flow meter shall be used to provide an accurate quantity of water diverted as required for the annual water use report (including the meter reading at the beginning and end of the report year).
- 13. That the applicant shall maintain accurate and complete records from which the quantity of water diverted during each calendar year may be readily determined and the applicant shall file an annual water use report with the Chief Engineer by March 1, following the end of each calendar year. Failure to file the annual water use report by the due date shall cause the applicant to be subject to a civil penalty.
- 14. That no water user shall engage in nor allow the waste of any water diverted under the authority of this permit.

- 15. That the right to appropriate water under authority of this permit is subject to any minimum desirable streamflow requirements identified and established pursuant to K.S.A. 82a-703c for the source of supply to which this water right applies.
- 16. That failure without cause to comply with provisions of the permit and its terms, conditions and limitations will result in the forfeiture of the priority date, revocation of the permit and dismissal of the application.

If you need an extension of time, you must request it before the deadline for completion set forth in the permit. Any request for an extension of time must be accompanied by the statutorily required fee, which is currently \$100.00.

An annual water use report must be filed with the Chief Engineer by March 1, following the end of each calendar year. If a complete annual water use report is not received by the deadline, then a fine may be assessed and all water use under such permit or right may be suspended. Reports submitted in paper form will be assessed a \$20 per file number paper filing fee. In order to avoid this filing fee, you may submit your report online at www.kswaterusereport.org.

The approval of your application constitutes a permit to appropriate water. It does not give authority to construct any dam or other stream obstruction regulated by K.S.A. 82a-301 through 305a. It does not give authority to access any right-of-way or authorize trespassing upon or injury to public or private property. It may also be necessary for you to comply with other local, state or federal requirements.

Enclosed is an informational sheet that sets forth the procedure to obtain a Certificate of Appropriation which will establish the extent of your perfected water right. Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Division, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for review may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
