K & K Land LLC C/O Benson Keil has filed the referenced change applications for a place of use change to form a complete overlap with New Application, File Nos. 49,916 & 49,917 (still pending as of the date of this memo). There is no proposed change in the rate or quantity for any of the above referenced files.

The files do not appear to be abandoned as per K.A.R. 82a-718.

Currently, all the above referenced files overlap in place of use. The change in place of use for all the above referenced files will add 33.25 acres in Section 13, Township 5 S, Range 3 West; 184 acres to Section 19, Township 5 South, Range 2 West; 10 acres to Section 24, Township 5 South, Range 3 West, 20 acres to Section 25, Township 5 South, Range 3 West and 59 acres to Section 30, Township 5 South, Range 2 West for a total of 306.25 acres all in Cloud County, Kansas. This will create a complete overlap in place of use with New Application File Nos. 49,916 & 49,917. The proposed place of use is owned by K & K Land LLC and Hazel Kiel Trust #1 Benson Keil Trustee and all signatures required to change the place of use have been received.

New Application, File No. 49,916 proposes the appropriation of 400 acre-feet from two (2) pumpsites located on the Republican River. New Application, File No. 49,917 proposes the appropriation of 120 acre-feet, limited to senior files, from a battery of four (4) wells located in Section 13, Township 5 South, Range 13 West. When combining the new applications with all the change applications referenced above, the combined quantity authorized on the proposed place of use is 1,492.075 acre-feet. This comes out to be 1.3 acre-feet per acre, which the maximum allowable for Cloud County (1.3). New Application File No. 49,917 is still pending further investigation by the Stockton Field Office. Even without the approval of New Application File No. 49,917 the combined quantity with New Application, File No. 49,916 comes out to be 1.27 acre-feet per acre and is reasonable to justify the change in place of use applications for the above referenced files on its own.

Nearby notifications were completed with the new applications. The applicant identified 1 domestic well and 8 landowners upstream and downstream within ½ mile of the proposed points of diversion/ land for the new applications. Nearby notification letters were sent out on March 28, 2018. One (1) phone call was received from nearby landowners along the Republican River to obtain more information on the proposed applications. No official letters were received.

In a July 27, 2018 e-mail, Kelly Stewart, Water Commissioner, Stockton Field Office, recommended approval of the application.

Based on the above discussion, that the change is reasonable, the historical consumptive use will not substantially be increased due to the approval of the new appropriations, impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it is recommended that the referenced applications be approved.

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 39,384, for permit to appropriate water for beneficial use, is as stated and set forth in the Certificate of Appropriation dated April 1, 1997, as modified and amended by the aforementioned orders.

This Order shall become a final agency action, as defined by K.S.A. 77-607(b), without further notice to the parties, if a request for hearing or a petition for administrative review is not filed as set forth below.

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may request an evidentiary hearing before the Chief Engineer, or request administrative review by the Secretary of Agriculture. Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Division, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for review may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.



I have spoken with Benson Keil and we're going to attempt to gather some field data while he pumps his existing wells next week. Mark plans on installing pressure transducers in one of his pumping wells and one in an existing stock well that is located near his proposed well locations. We plan on observing the drawdown in these wells and gain the data we need for Mark to come up with some real-life data and run it through Aqtesolve.

In the meantime, I have no objection to the approval of File No. 49,916. Benson would like us to move forward on this application as soon as possible so he can start making arrangements. If the approval of 49,916 would be sufficient to justify the increase in acres proposed under his existing files, I would recommend we go ahead and process those.

As a matter of record, the Division of Water Resources has on hand a large number of applications awaiting processing. Therefore, to be fair to all concerned, and so that we can process those applications on hand in the order they were received, we intend to concentrate on the backlog of applications until the issue is resolved. You will be contacted regarding this application as soon as it has been examined.

In accordance with the provisions of the Kansas Water Appropriation Act, a portion of which is included below, the use of water prior to approval of the application is unlawful. You should not proceed and divert water as indicated by your plans in your application for a change for this file until you receive approval for this change from the Chief Engineer. Once approved, compliance with the terms, conditions and limitations of the permit is necessary. Conservation of the water resources of Kansas is required.

Section 82a-728 of the Kansas Water Appropriation Act, provides (a) except for the appropriation of water for the purpose of domestic use, . . . it shall be unlawful for any person to appropriate or threaten to appropriate water from any source without first applying for and obtaining a permit to appropriate water in accordance with the provisions of the Water Appropriation Act or for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.

(b) (1) The violation of any provision of this section by any person is a class C misdemeanor...

A class C misdemeanor is punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. Each day that the violation occurs constitutes a separate offense.
