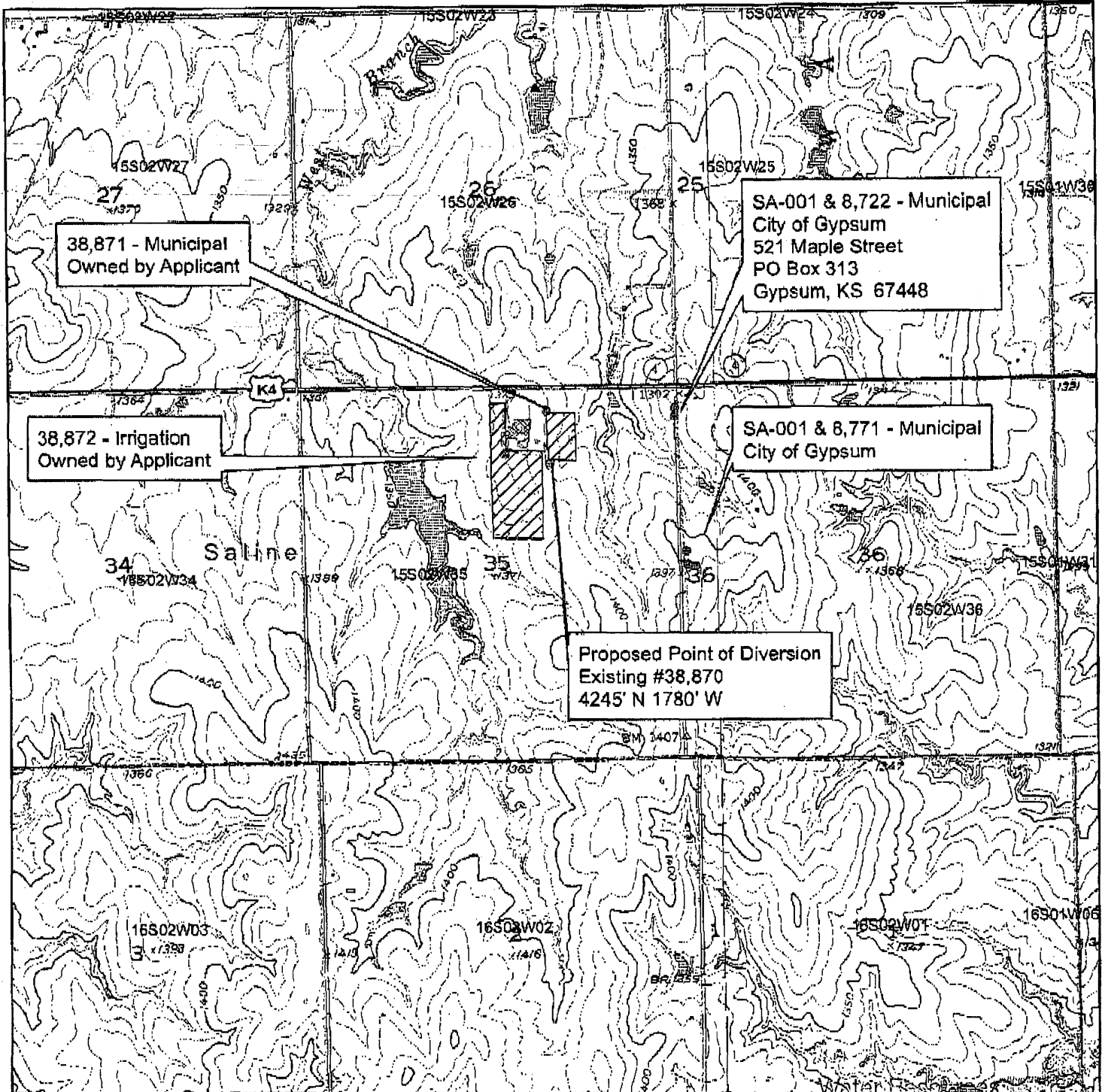

● Groundwater Point of Diversion

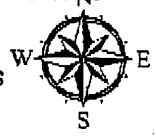
