Any use of water that is not as authorized by the water right or permit to authorize water **before** the chief engineer approves this application is a violation of the Kansas Water Appropriation Act for which criminal or civil penalties may be assessed. Such violation is a class C misdemeanor, punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. K.S.A. 82a-728(b). Civil penalties shall be not less than \$100 nor more than \$1,000 per violation. In the case of a continuing violation, each day such violation continues may be deemed a separate violation. In addition to these penalties the water right may be modified or suspended. K.S.A. 82a-737, as amended.

The application must be signed by all owners of the place of use authorized under the water right and his or her spouse, if married. Please indicate if there is no spouse. If land is being purchased under contract, the seller must sign as landowner until such time as the contract is completed.

In the event that all applicants cannot appear before one notary public, they may as necessary sign separate copies of the application before any notary public conveniently available to them. All copies signed in this manner shall be considered to be valid parts of the application.

If the request is signed on behalf of any Owner by someone with legal authority to do so (for example, an agent, one who has power of attorney, or an executor, executrix, conservator), it will be necessary to attach proper documents showing such authority.

I declare that I am an owner of the currently authorized place of use as identified herein, or that I represent all such owners and am authorized to make this application on their behalf, and declare further that the statements contained herein are true, correct, and complete. 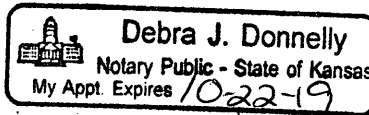

Marshal, enclosed are a series of applications that upon approval will allow your center pivot to travel over on the ground you recently purchased. Below, I have outlined what you need to do to finish the applications.

Application for Permit to Appropriate Water - This application has a #1 in the upper left-hand corner of the first page. This application will provide for additional water rights on the South well. The North well has 125 acre-feet and upon approval of this application the South well will have 147 acre-feet. To finish the application, please do the following:

#1) Sign and date the application in Item #'s 6 & 16

#2) There is a form included with the application that references "Minimum Desirable Streamflow". This form will need to be signed and dated in the presence of a notary.

#3) The filing fee for this application is \$300.

Application to Change the Place of use (File Nos. 45779 & 28461) – Each of these applications has a #2 in the upper left-hand corner of the first page of the application. The purpose of these applications is to add the land you recently purchased to your existing water rights. To finish these applications, you and your wife will need to sign them in the presence of a **notary**. The filing fee for each application is \$200.

To cover all the filing fees you can provide one check for \$700 payable to the Kansas Dept of Agriculture.

As a side-note, I talked to George Hieger and he informed me of the deal you guys have where you will be selling them the 40 acre tract that you own on the East side of the road. As part of the applications above, we will be removing that 40 acre tract from your water rights. I will be sending them separate signature pages because by the time that these applications are processed they will own that 40 acre tract. I will handle that transaction.

Dear Sir or Madam:

An application for approval of the Chief Engineer to change the following condition or conditions of the file number referred to above has been received:

- place of use PU
- point of diversion
- use made of water

As a matter of record, the Division of Water Resources has on hand a large number of applications awaiting processing. Therefore, to be fair to all concerned, and so that we can process those applications on hand in the order they were received, we intend to concentrate on the backlog of applications until the issue is resolved. You will be contacted regarding this application as soon as it has been examined.

In accordance with the provisions of the Kansas Water Appropriation Act, a portion of which is included below, the use of water prior to approval of the application is unlawful. You should not proceed and divert water as indicated by your plans in your application for a change for this file until you receive approval for this change from the Chief Engineer. Once approved, compliance with the terms, conditions and limitations of the permit is necessary. Conservation of the water resources of Kansas is required.

Section 82a-728 of the Kansas Water Appropriation Act, provides (a) except for the appropriation of water for the purpose of domestic use, . . . it shall be unlawful for any person to appropriate or threaten to appropriate water from any source without first applying for and obtaining a permit to appropriate water in accordance with the provisions of the Water Appropriation Act or for any person to violate any condition of a vested right, appropriation right or an approved application for a permit to appropriate water for beneficial use.

(b) (1) The violation of any provision of this section by any person is a class C misdemeanor...

A class C misdemeanor is punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. Each day that the violation occurs constitutes a separate offense.

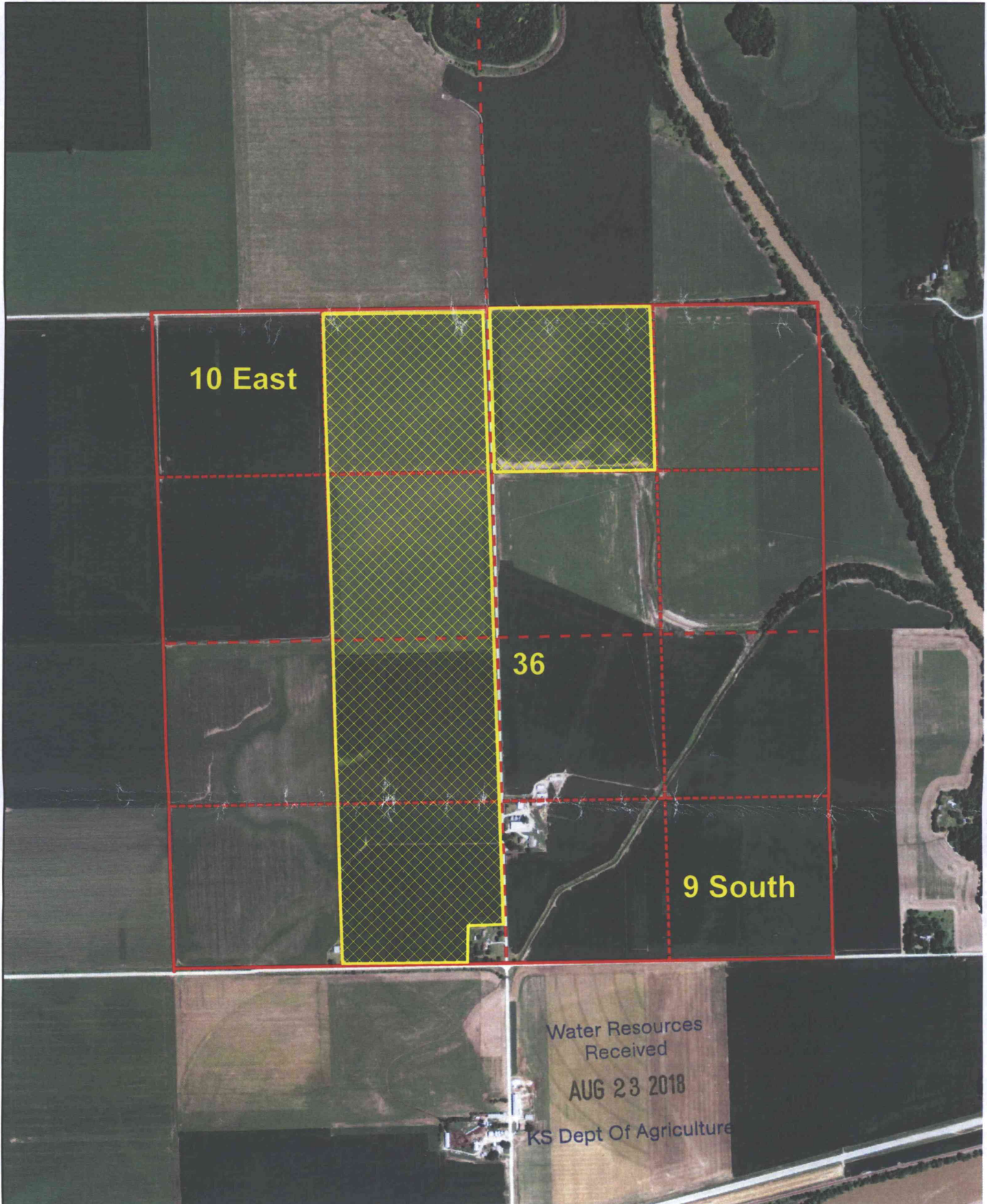

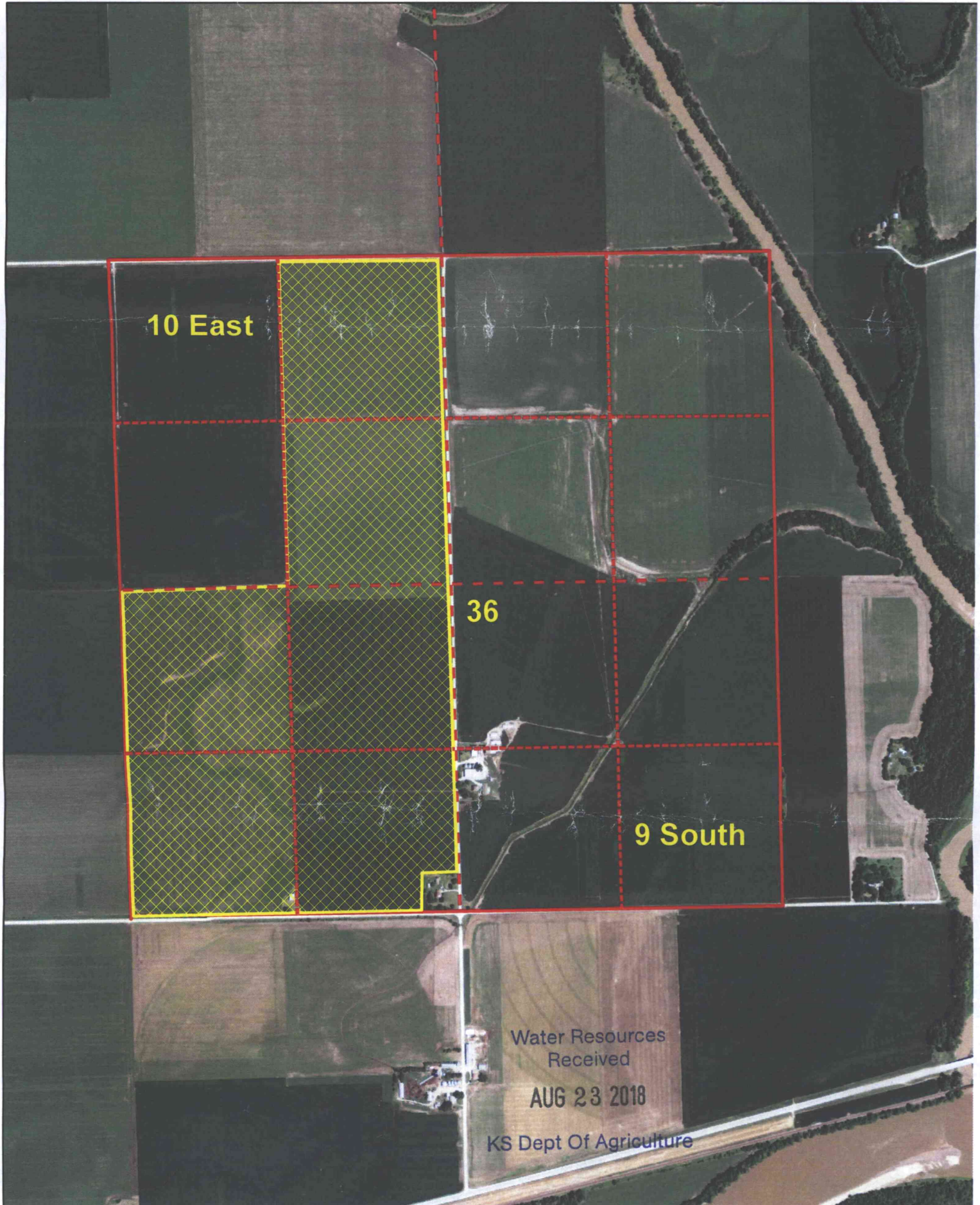
