

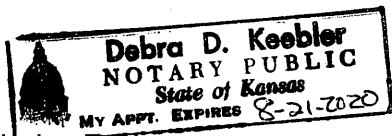

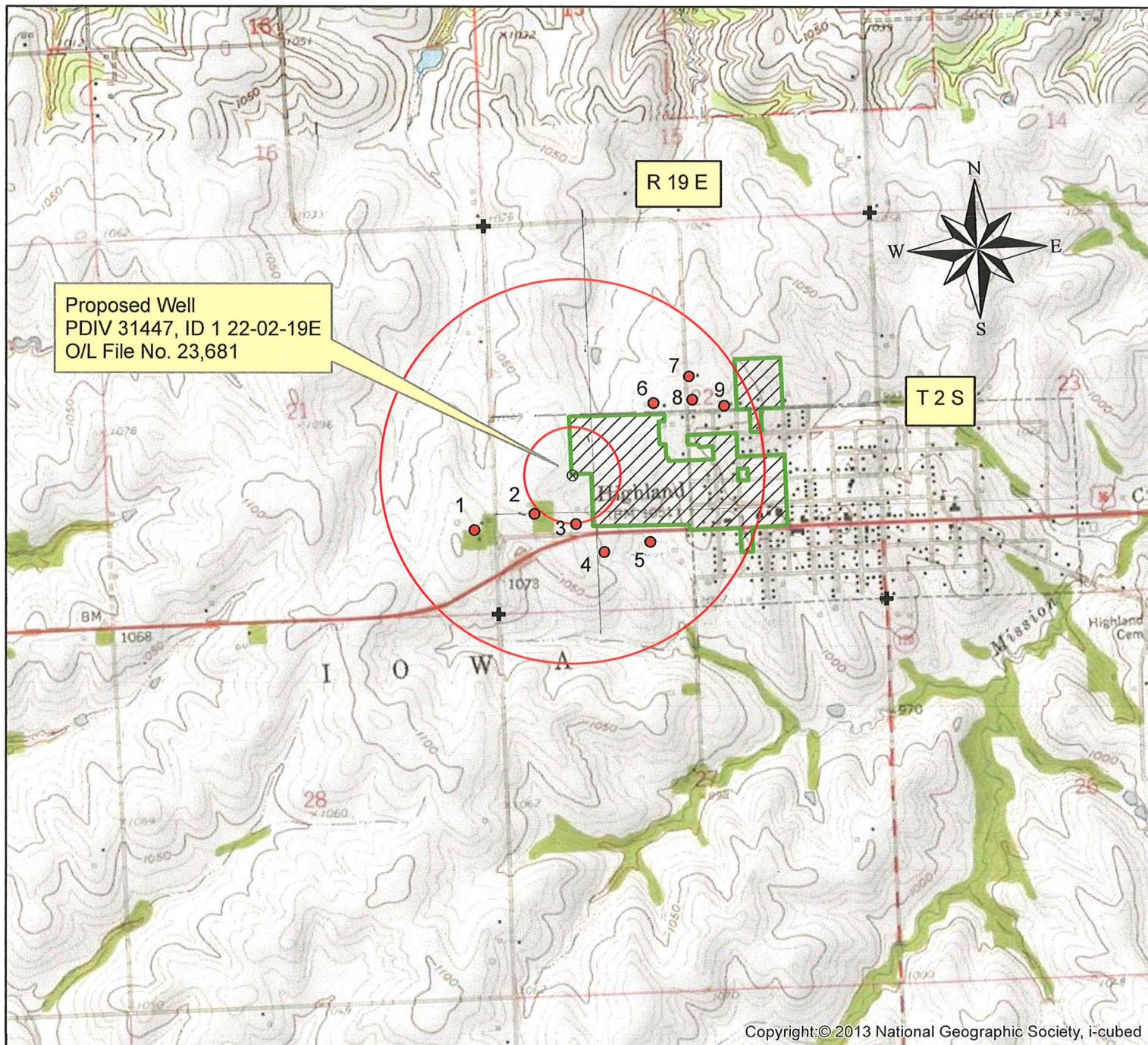

Owners of Potential Domestic Wells Within ½-Mile of Proposed Well



