John Gorentz, Utilities Supervisor, City of Arma, has filed applications for approval to change the place of use for the reference file numbers which are authorized the diversion of groundwater for municipal use. The applications were received on November 8, 2019.

The referenced rights appear not be abandoned as per K.S.A. 82a-718, and in compliance with K.S.A. 82a-732. A 2013 compliance check by the Topeka Field Office did not indicate any major problems. The actual points of diversion were updated by the 2013 changes. It appears the applications comply with K.A.R. 5-5-2a, *Complete change application*. As the applications propose to change the place of use without any additional increase in the place of use, no notification of nearby well owners will be necessary per K.S.A. 82a-1906.

The proposed change to the place of use appears to be due to the reorganization of Crawford Rural Water District No. 7 being absorbed by Crawford Rural Water District No. 2.

The referenced files overlap in the place of use which is currently described as:

The City of Arma and immediate vicinity; the City of North Arma and immediate vicinity, and the City of Franklin and immediate vicinity and within the boundaries of Crawford Rural Water District No. 7 and immediate vicinity.

The authorized place of use will be updated to list the RWD as No. 2 and will also include the county and state designation that is now the practice.

The City of Arma and immediate vicinity; the City of North Arma and immediate vicinity; the City of Franklin and immediate vicinity; and within the boundaries of Crawford Rural Water District No. 2 and immediate vicinity, all in Crawford County, Kansas.

The approvals should not result in pumping in excess of the authorized quantity due to the historical purchasing of water. The change in place of use appears to comply with K.A.R. 5-5-3, *Historical consumptive use*.

Water flow meters meeting the specifications of the Chief Engineer will continued to be required. A check valve on each well will be required if any chemical or foreign substance is injected into the water through either of the diversion works.

Katie Tietsort, Water Commissioner of the Topeka Field Office has recommended approval of the proposed changes per her email dated February 19, 2020.

Based on the above discussion, that the change to the place of use is reasonable, will not result in an increase in consumptive use, that impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it is recommended that the referenced applications for change be approved.

Any use of water that is not as authorized by the water right or permit to authorize water **before** the chief engineer approves this application is a violation of the Kansas Water Appropriation Act for which criminal or civil penalties may be assessed. Such violation is a class C misdemeanor, punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. K.S.A. 82a-728(b). Civil penalties shall be not less than \$100 nor more than \$1,000 per violation. In the case of a continuing violation, each day such violation continues may be deemed a separate violation. In addition to these penalties the water right may be modified or suspended. K.S.A. 82a-737, as amended.

The application must be signed by all owners of the place of use authorized under the water right and his or her spouse, if married. Please indicate if there is no spouse. If land is being purchased under contract, the seller must sign as landowner until such time as the contract is completed.

In the event that all applicants cannot appear before one notary public, they may as necessary sign separate copies of the application before any notary public conveniently available to them. All copies signed in this manner shall be considered to be valid parts of the application.

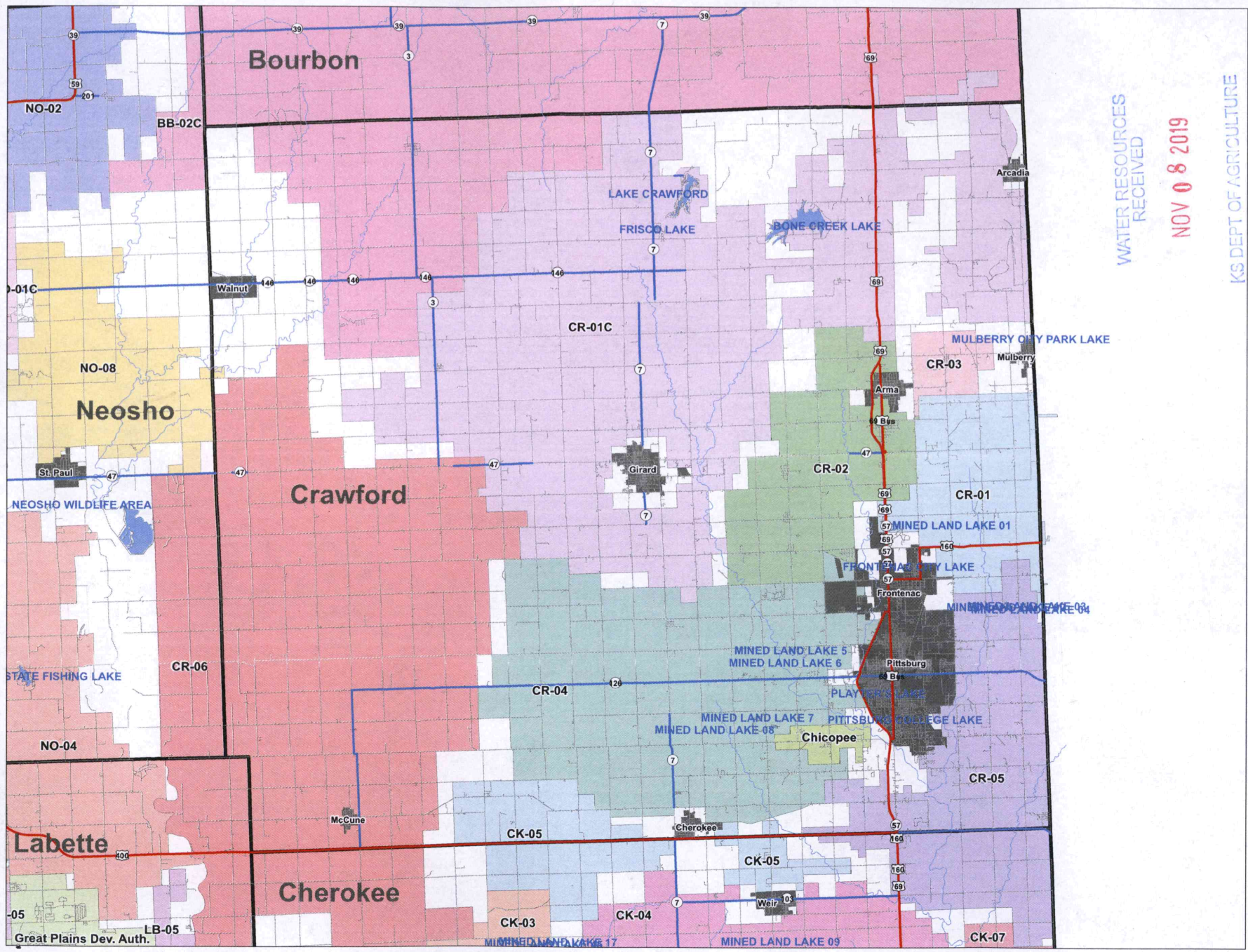

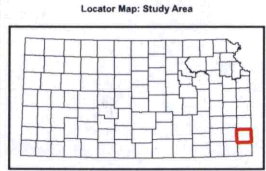

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of John Gorentz, Utilities Supervisor, for the City of Arma, 701 E. Washington, PO Box 829, Arma, Kansas 66712, received in this office on November 8, 2019, for approval of a change in the location of the place of use under the certificate of appropriation issued pursuant to the permit to appropriate water for beneficial use, as modified and amended by the Order of the Chief Engineer dated May 9, 2012, approving the application to change the place of use and to more accurately describe the location of the authorized point of diversion, finds that the change is reasonable and will not impair existing rights, that the change relates to the same local source of supply and that the application should be and is hereby approved.

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the authorized place of use shall be:

the City of Arma and immediate vicinity; the City of North Arma and immediate vicinity; the City of Franklin and immediate vicinity; and within the boundaries of Crawford Rural Water District No. 2 and immediate vicinity, all in Crawford County, Kansas,

located substantially as shown on the plat accompanying the application to change the place of use.

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., **within a total of 18 days after this Order was mailed to you**), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., **within a total of 33 days after this Order was mailed to you**), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
