File No. 49,192

Steven V. and Janice Peterson, owner of the referenced file number, filed an application for approval to change the point of diversion for File No. 49,192. The referenced file number is authorized surface water from Republican River for irrigation use.

The referenced file number does not appear abandoned as per K.S.A. 82a-718. The perfection period expires December 31, 2020.

File No. 49,192 is authorized one pumpsite located 4,420 feet North and 420 feet West of the Southeast corner of Section 13, Township 8 South, Range 2 East, Clay County, for irrigation of 644 acres in Sections 17, 18, 19, and 20, Township 8 South, Range 3 East, Clay County. File No., 49,192 has no overlaps in the point of diversion but the place of use overlaps Water Right File Nos. 19,379 and 47,111 and is limited to 760 acre-feet when combined with Water Right, File Nos. 19,379 and 47,111. The water right owner proposes to add a pumpsite approximately 8,427 feet downstream at a point located 2,561 feet North and 1,523 feet West of the Southeast corner of Section 18. It appears that the same local source of supply will not change. There are two pumpsites authorized by Water Right, File No. 5,679, one by File No. 45,169, one by File No. 47,546, and one by File No. 39,549 located between the presently authorized and proposed pumpsite locations.

Paragraph No. 17 indicates that the proposed change relates to the same local supply as there is no tributary streams between the existing pumpsite and the proposed second pumpsite, that the proposal will not impair existing water rights, since minimum desirable streamflow administration will be in effect during low flow conditions when the priority of this permit in relation to neighboring water rights is most likely to be in question.

Nearby landowners located one-half (½) mile upstream and downstream from land owned or controlled by the applicant were notified of the proposed changes in point of diversion by letters dated February 17, 2020; one phone call was received inquiring about the proposal but no objections were indicated.

In a March 13, 2020 e-mail, Katherine Tietsort, Water Commissioner of the Topeka Field Office, indicated that she has no objections to approval of the application.

A water flow meter is required. A check valve is required if any chemical or foreign substance is injected into the water through the diversion works.

Based on the above discussion, that the changes are reasonable, that impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it has been recommended that the referenced application be approved.

Any use of water that is not as authorized by the water right or permit to authorize water <u>before</u> the chief engineer approves this application is a violation of the Kansas Water Appropriation Act for which criminal or civil penalties may be assessed. Such violation is a class C misdemeanor, punishable by a fine not to exceed \$500 and/or a term of confinement not to exceed one month in the county jail. K.S.A. 82a-728(b). Civil penalties shall be not less than \$100 nor more than \$1,000 per violation. In the case of a continuing violation, each day such violation continues may be deemed a separate violation. In addition to these penalties the water right may be modified or suspended. K.S.A. 82a-737, as amended.

The application must be signed by all owners of the place of use authorized under the water right and his or her spouse, if married. Please indicate if there is no spouse. If land is being purchased under contract, the seller must sign as landowner until such time as the contract is completed.




Authorized Place of Use (644 acres)

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Steven V. and Janice Peterson, 1931 4th Street, Clay Center, Kansas 67432-1742, received in this office on July 25, 2019, for approval of a change in the location of the point of diversion under Approval of Application, File No. 49,192, for permit to appropriate water for beneficial use, as modified and amended by the Order of the Chief Engineer dated June 10, 2019, approving the application to change the place of use, finds that the change is reasonable and will not impair existing rights, and that the application should be and is hereby approved.

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the authorized locations of the points of diversion shall be:

one (1) pumpsite located in Lot 1 of Section 13, more particularly described as being near a point 4,420 feet North and 420 feet West of the Southeast corner of said section, in Township 8 South, Range 2 East, and

one (1) pumpsite located in the Northeast Quarter of the Northwest Quarter of the Southeast Quarter (NE½ NW½ SE½) of Section 18, more particularly described as being near a point 2,561 feet North and 1,523 feet West of the Southeast corner of said section, in Township 8 South, Range 3 East,

both in Clay County, Kansas,

located substantially as shown on the map accompanying the application to change the point of diversion.

Installation of the works for diversion of water shall be completed on or before December 31, 2020, or within any authorized extension of time. The water right owner shall notify the Chief Engineer of the Division of Water Resources, Kansas Department of Agriculture, when construction of the works for diversion has been completed.

All diversion works into which any type of chemical or other foreign substance will be injected into the water pumped from the diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Approval of Application, File No. 49,192, for permit to appropriate water for beneficial use, is as stated and set forth in the approval dated April 9, 2015, as modified and amended by the aforementioned order.

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with: Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for hearing may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with: Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, KS 66502, FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.
