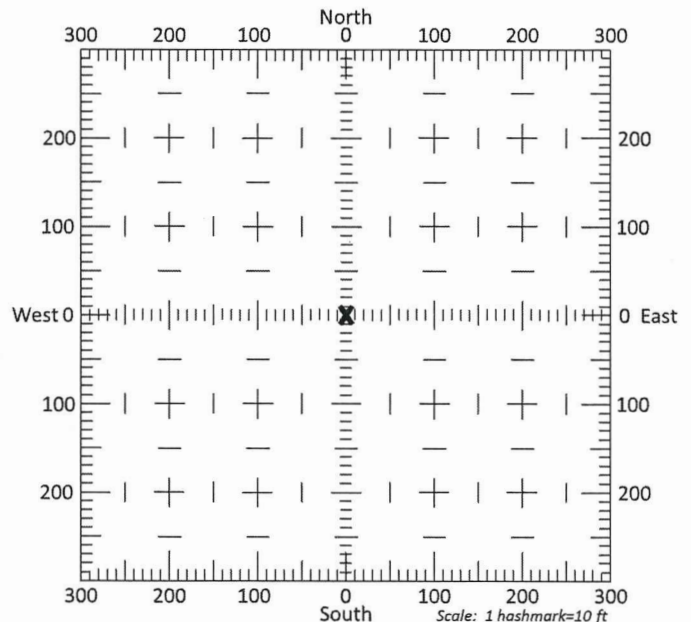

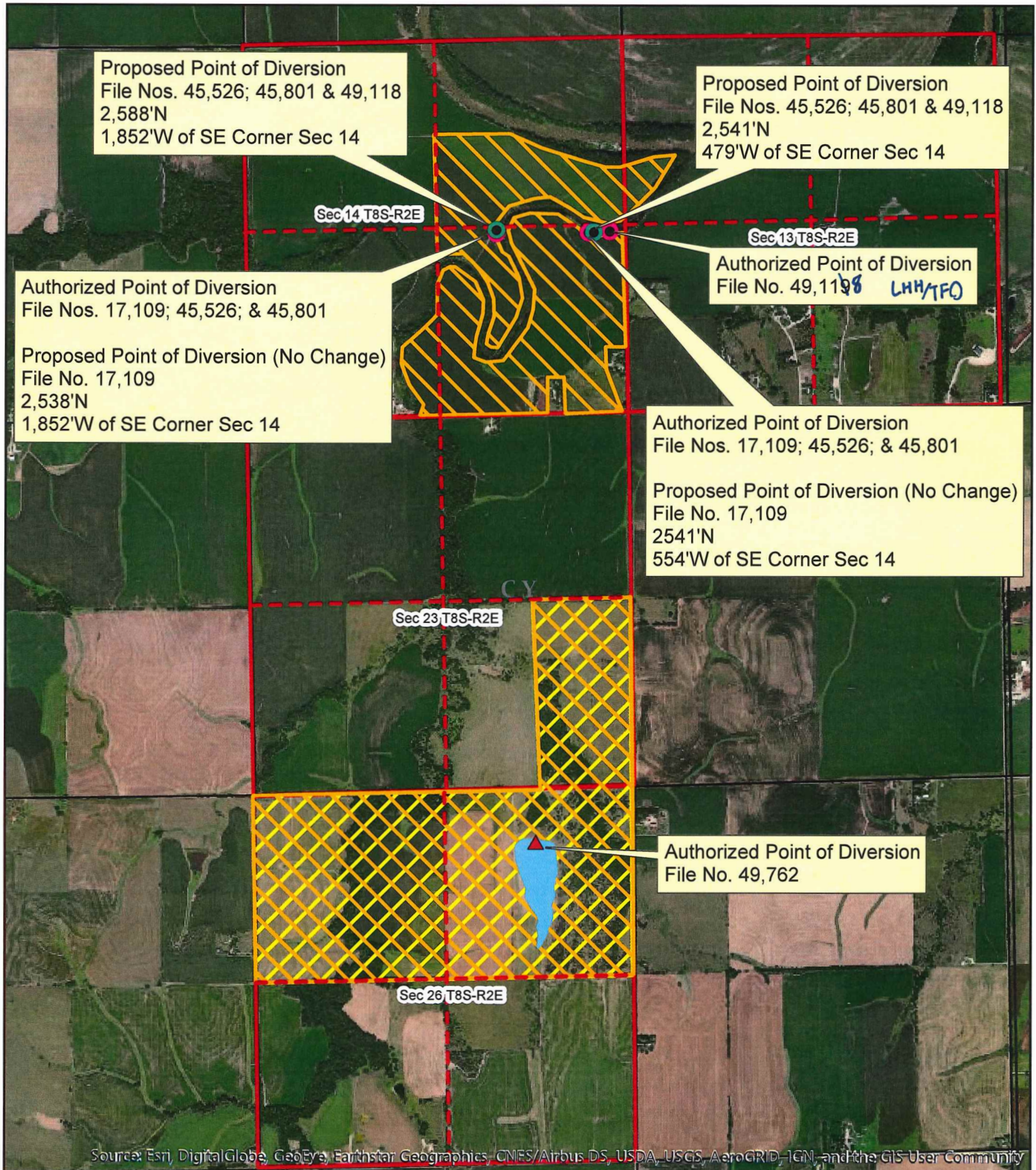

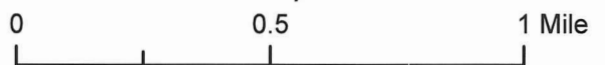


Proposed Place of Use
