Paul Heinen, on behalf of Rural Water District No. 3, Jefferson County, Kansas, has filed applications for approval to change the place of use for the referenced file numbers; authorized for municipal use.

The referenced file numbers do not appear abandoned as per K.S.A. 82a-718.

The referenced file numbers overlap in their authorized point of diversion and place of use, described as within the boundaries of Rural Water District Nos. 3 and 6, Jefferson County, Kansas.

As indicated in a letter to the district dated April 9, 2021, from Tyler Smith, Environmental Compliance Specialist of the Topeka Field Office, the 2019 and 2020 water use reports indicated that Jefferson Rural Water District No. 3 sold water to Jefferson Rural Water District No. 11, which resulted in the above file nos. being out of compliance (by serving water on land not authorized under the water rights). The three place of use applications were prepared to remedy this, adding Jefferson Rural Water District No. 11 to the authorized place under each file no.

Ten well owners within ½ mile of the existing point of diversion were identified. Nearby notification letters were mailed on November 16, 2021, to inform said landowners of the pending change applications.

The same local source of supply will not change, which has previously been determined to be Kansan stage (140).

In an e-mail dated November 16, 2021, Katie Tietsort, Water Commissioner of the Topeka Field Office, indicated no objection to approval of the referenced change applications.

A water flow meter is required. Check valves will be required if chemigating.

Based on the above discussion, that the changes are reasonable, that impairment to existing water rights is unlikely, and that no change in the local source of supply will occur, it is recommended that the referenced applications be approved

APPROVAL OF APPLICATION FOR CHANGE IN PLACE OF USE WATER RIGHT FILE NO. 43,428

The Chief Engineer, Division of Water Resources, Kansas Department of Agriculture, after due consideration of the written application of Paul Heinen, on behalf of Rural Water District No. 3, Jefferson County, Kansas, PO Box 129, Valley Falls, Kansas, 66088, received in this office on April 29, 2021, for approval of a change in the location of the place of use made of water under the Approval of Application, File No. 43,428, pursuant to the application for permit to appropriate water for beneficial use, finds that the change is reasonable and will not impair existing rights, and that the application should be and is hereby approved.

The effective date of the change shall be the date this order is executed by the Chief Engineer, after which the authorized location of the municipal place of use shall be:

within the boundaries of Rural Water District No. 3, 6, and 11, Jefferson County, Kansas.

All diversion works shall be equipped with an in-line, automatic, quick-closing check valve capable of preventing pollution of the source of the water supply. The type of valve installed shall meet specifications adopted by the Chief Engineer and shall be maintained in an operating condition satisfactory to the Chief Engineer.

The water right owner shall properly install an acceptable water meter on the diversion works authorized under this water right, prior to the use of water, in strict accordance with the Kansas Administrative Regulations 5-1-4 through 5-1-12 adopted by the Chief Engineer. The water right owner shall notify the Chief Engineer when installation of the water meter has been completed. The water right owner shall maintain the water meter in an operating condition satisfactory to the Chief Engineer, at all times during diversion of water and shall maintain records from which the total quantity of water diverted may be determined. The water right owner shall also report the reading of said water meter and the total quantity of water diverted annually to the Chief Engineer. Such records shall be furnished to the Chief Engineer by March 1 following the end of each calendar year.

In all other respects, the Certificate of Appropriation issued pursuant to Approval of Application, File No. 43,428, for permit to appropriate water for beneficial use, is as stated and set forth in the approval dated December 28, 1998.

RIGHT TO A HEARING AND TO ADMINISTRATIVE REVIEW

If you are aggrieved by this Order, then pursuant to K.S.A. 82a-1901, you may:

- 1) request an evidentiary hearing before the Chief Engineer, or
- 2) request administrative review by the Secretary of Agriculture.

Failure to request an evidentiary hearing before the Chief Engineer does not preclude your right to administrative review by the Secretary.

To obtain an evidentiary hearing before the Chief Engineer, a written request for hearing must be filed within 15 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 18 days after this Order was mailed to you), with the Kansas Department of Agriculture, Attn: Legal Section, 1320 Research Park Drive, Manhattan, Kansas 66502, or by FAX (785) 564-6777.

If you do not file a request for an evidentiary hearing before the Chief Engineer, you may petition for administrative review of the Order by the Secretary of Agriculture. A petition for review shall be in writing and state the basis for requesting administrative review. The request for review may be denied if the request fails to clearly establish factual or legal issues for review. See K.S.A. 77-527. The petition must be filed within 30 days after service of this Order as provided in K.S.A. 77-531 (i.e., within a total of 33 days after this Order was mailed to you), and be filed with the Secretary of Agriculture, Attn: Legal Division, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, or by FAX (785) 564-6777.

If neither a request for an evidentiary hearing nor a petition for administrative review is filed as set forth above, then this Order shall be effective and become a final agency action as defined in K.S.A. 77-607(b). Failure to timely request either an evidentiary hearing or administrative review may preclude further judicial review under the Kansas Judicial Review Act.

Any request for hearing or petition for administrative review shall be in writing and shall be submitted to the attention of: Chief Legal Counsel, Kansas Department of Agriculture, 1320 Research Park Drive, Manhattan, Kansas 66502, Fax: (785) 564 - 6777.
