1. The fee for an application for a permit to appropriate water for beneficial use, except for domestic use, shall be (see paragraph No. 2 below if requesting storage):

2. The fee for an application in which storage is requested, except for domestic use, shall be:

More than 250	\$200.00 plus \$20.00 for each additional 250 acre-feet of storage or any part thereof.

Note: If an application requests both direct use *and* storage, the fee charged shall be as determined under No. 1 or No. 2 above, whichever is greater, but not both fees.

3. The fee for an application for a permit to appropriate water for water power or dewatering purposes shall be \$100.00 plus \$200.00 for each 100 cubic feet per second, or part thereof, of the diversion rate requested.

Note: The applicant shall notify the Chief Engineer and pay the statutorily required field inspection fee of \$400.00 when construction of the works for diversion has been completed, except that for applications filed on or after July 1, 2009, for works constructed for sediment control use and for evaporation from a groundwater pit for industrial use shall be accompanied by a field inspection fee of \$200.00.

A Water Conservation Plan may be required per K.S.A. 82a-733. A statement that your application for permit to appropriate water may be subject to the minimum desirable streamflow requirements per K.S.A. 82a-703a, b, and c may also be required from you. After the Division of Water Resources has had the opportunity to review your application, you will be notified whether or not you will need to submit a Water Conservation Plan. You also may be required to install a water flow meter or water stage measuring device on your diversion works prior to diverting water. 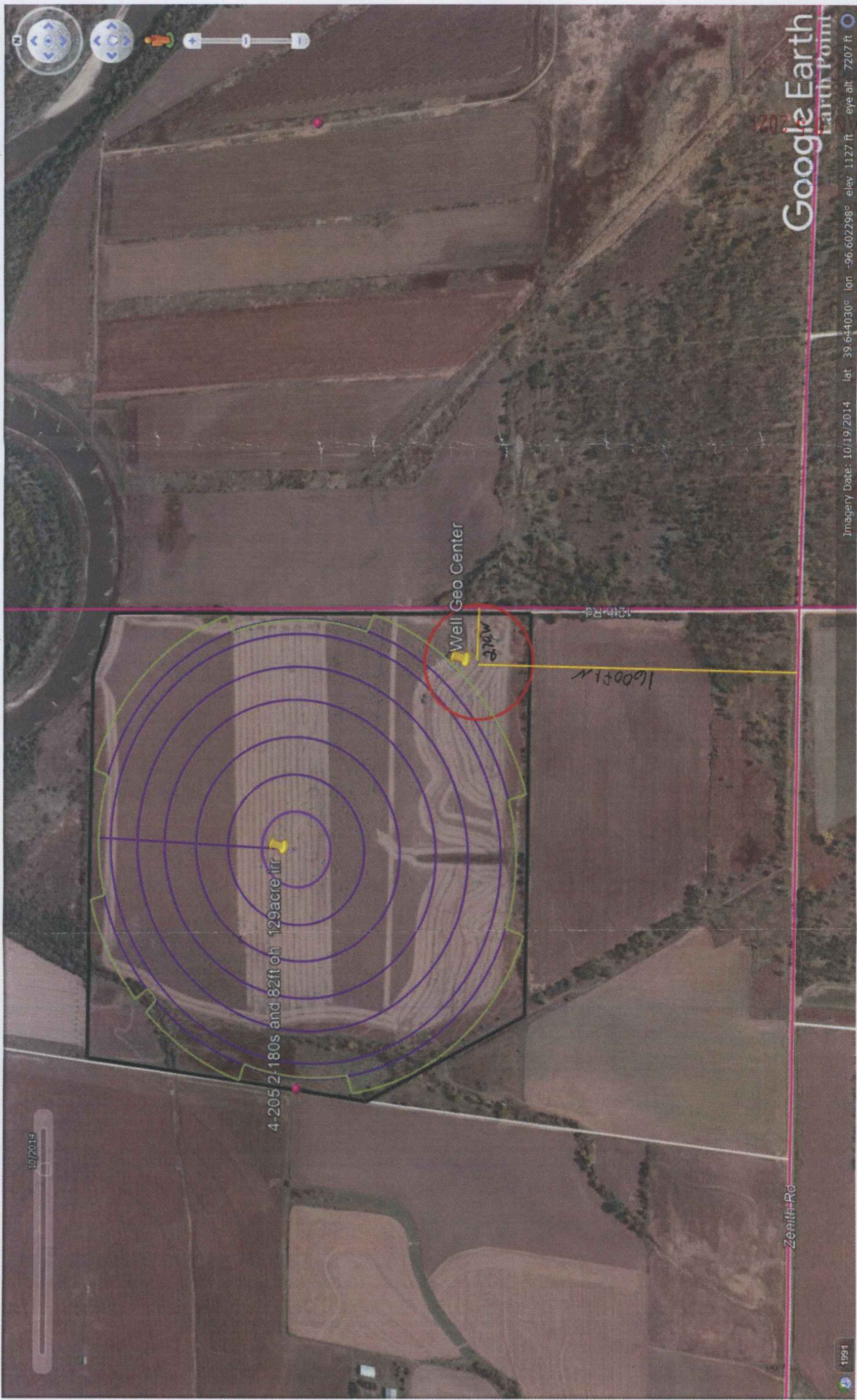

Dear Kristen:

Recent test drilling on this farm revealed that the currently proposed well location for this application is not a viable place to drill a well. Additional test drilling found a decent water supply about 1900 feet North, however, it is still a question on how productive the well will be. With this question unanswered we would like to have the option to complete a battery of three wells that will be located as follows:

One well – NE SE NE 3680'N & 80'W 2-5-7E
One well – NE SE NE 3430'N & 80'W 2-5-7E
One well – SE SE NE 3180'N & 80'W 2-5-7E
GEO CTR – NE SE NE 3430'N & 80'W 2-5-7E

Research at the geographic center of the battery would indicate that the safe yield is only 115 acre-feet. Please reduce the quantity on the application accordingly.

It should also be noted that there are no wells of any kind located within one-half mile of the proposed point of diversion.

Included with this letter is a test hole log and an aerial photo. Please note that the aerial photo only represents a proposal to construct a battery of 2 wells. Please modify it to represent a proposal for a battery of 3 wells.
