

**ADDENDUM TO THE
CONSENT AGREEMENT AND ORDER DESIGNATING A WATER
CONSERVATION AREA
COMPTON: LANE COUNTY FARM WATER CONSERVATION AREA (2022-2027)**

This addendum effectively reduces the corrective control provision of the current Consent Agreement and Order Designating a Water Conservation Area. With this addendum it amends the Compton: Lane County Farm Water Conservation Area management plan.

Amendments to the Corrective controls:

- The duration shall be amended for the current 2nd five-year period of the WCA, to a six-year period, to expire at the end of December 31, 2027, and shall also cause the WCA to expire after December 31, 2027.
- The allocation value shall be expressed in terms of total water volume of a six-year period.
- Goal Expression: not to exceed 1,855 Acre Feet (AF) in the current six-year period (309.2 AF x 6) beginning January 1, 2022, and ending December 31, 2027; not to exceed 576 AF annually.
- Unused water from the recent preceding five-year WCA allocation period shall not be carried over to reference amended six-year period.
- Up to 25% of the annual WCA allocation may be carried over and added to a subsequent WCA period after 2027; if unused during the duration of this amended WCA period. For the carryover quantity to be included, all owners must enter into agreement to participate in a subsequent WCA by December 31st of the last year of this amended WCA period.

FOR THE PARTICIPANTS: By signing this addendum, we the undersigned, hereby agree to the amendments made to the Compton: Lane County Farm WCA. All other terms and conditions of the Compton: Lane County Farm WCA dated February 14, 2017, are still in effect and agreed to. We also agree, as owners, that water rights remaining may be removed by written request to the Chief Engineer designating the water right(s) to be removed, lands to be removed, and needed adjustments to overall allocations and flexibilities provided to such water rights. Such adjustment shall be proportional to the water right(s) removed and total authorization by the WCA, if applicable.
